Dear Mr. Mikulich:

This agency has reviewed Geo-Logic's letter dated May 19, 2000 in response to the November 30, 1999 letter issued by this office regarding the Risk Management Plan (RMP) submitted for the above referenced site. As discussed during our on-site meeting of June 8, 2000 which was also attended by Joel Greger, your consultant and our teleconference today with the US Postal Service represented by Mr. Kayode Kadara and Mr. Joseph Herbst, the construction risk management plan is acceptable with the following conditions:

- 1) The structure of the proposed building will be supported by shallow spread footings on and within the engineered fill material. Therefore, contaminated soil is not expected to be encountered and contact with groundwater is not expected to occur during construction activities at the site. In addition, no conduits will be created for contaminants to migrate from shallow to deeper groundwater.
- 2) If contaminated soil is encountered at the site, reuse of soil on site must have prior approval from this office. Soil should be characterized and disposed appropriately.
- 3) If unusual conditions are encountered during construction such as the presence of pipings, tanks or soil contamination, this office should be notified in a timely fashion.
- Dust control and stormwater preventive measures must be in place during construction activities at the site.

Please notify our office when construction will begin at the subject site.

It is my understanding that you and Mr. Kayode Kadara of the US Postal Service will be responsible in implementing the approved construction risk management plan.

Dear Mr. Mikulich:

This agency issued a "Remedial Action Completion Certification" for the above referenced property on January 6, 1999. However, a risk management plan (RMP) is required prior to any construction activities at the site. The RMP should include at a minimum the following items:

- 1) An acceptable health and safety plan to be followed during any activities involving exposure to soil and groundwater contamination
- 2) If soils and groundwater are generated during construction activities at the site, a soil management plan and groundwater management plan should be developed
- 3) Site mitigating measures to prevent any potential vertical conduits between the shallow and deeper aquifers
- 4) Description of site history, summary of the residual chemicals of concern in soil and groundwater and site development map showing areas to be landscaped, location of buildings, etc.

You will need to submit a deposit of \$1,000.00 payable to Alameda County Environmental Health Services for regulatory oversight on the subject site. At the completion of the project, any unused monies will be refunded to you or your designee. The deposit refund mechanism is authorized in Section 6.92.040L of the Alameda County Ordinance Code. Work on the project will be debited at the ordinance specified rate, currently at \$100 per hour.

This office is in receipt of the "Work Plan for Subsurface Investigation" dated September 27, 1993, submitted by Kaprelian Engineering, your consultant of record. Thank you for sending the information to our office in a timely manner.

Upon review of the report as submitted, this office concurs with the proposed plan for further investigation of the former streetcar facility. This would include continued sampling following the over-excavation of areas of known contamination.

Please provide a written report within thirty (30) days of the completion of the investigation. In the report please specify the remediation measures to be taken, concerning the contamination present in the monitoring wells (August 30, 1993, Keprealian Report).

Please be advised that in light of the time frame requested for approval of the current work plan, that further review will be needed prior to any further concurrence with future work at the site.
