
FIGURE 1	SITE LOCATION MAP .....	4

**EXECUTIVE SUMMARY**

This report was prepared at the request of the owner, Mr. Danny Chauhan. The purpose of the assessment was to identify conditions or activities which might represent a potential for site contamination. The information contained in this assessment is for the sole use of Mr. Chauhan and is intended to help provide environmental risk disclosure.

On January 13, 1994, the subject property, currently occupied by the Alliance Gas Station, was inspected by CEC. The assessment also included reviewing regulatory compliance, and hazardous waste site lists of the various federal and local environmental compliance agencies. Historical topographic maps were also reviewed as part of the Phase I Assessment. Historical aerial photographs and Sanborn Maps were requested for this site.

The site previously had a service garage which contained hydraulic lifts and may have contained an underground waste oil tank. The current site is a functioning gas station/convenience store and has three 10,000 gallon underground fuel tanks, which may or may not be contributing to a regional groundwater contaminant plume. There are sites upgradient of the property which may also be contributing to the regional groundwater contaminant plume. Therefore, CEC recommends that a Phase II Soil and Groundwater Investigation be conducted at the assessment site.

## SECTION 1.0 - INTRODUCTION & SCOPE OF WORK

A Phase I Environmental Site Assessment was performed by Certified Environmental Consulting, Inc. for Mr. Danny Chauhan of Hayward, California. Authorization to perform the assessment was given to CEC in writing by Mr. Kiran Khatri on January 7, 1994.

The work included the following tasks:

- Inspection of the facility for hazardous materials usage, storage, and disposal practices, including a review of commercial/industrial activities near the property.
- Review of site history through interviews and review of historical air photographs, and geological maps. Sanborn Historical Maps were not available for the assessment site.
- Review of neighboring property compliance assessments through regulatory database lists and case files for known fuel leaks or hazardous waste spills, and State records for hazardous waste or landfill sites.
- Review of site, topography, geology and hydrogeology.
- Preparation of this report.

## **SECTION 2.0 - SITE DESCRIPTION**

### **2.1 PRESENT USE AND IMPROVEMENTS:**

#### **2.1.1 SITE LOCATION:**

The assessment property is located at 20450 Hesperian Boulevard, Hayward, California (Alameda County). This area is zoned (C-1) Retail Business, according to the County of Alameda Zoning Department. Please see Figure 1 for the Site Location Map.

#### **2.1.2 SITE DESCRIPTION:**

The assessment property is rectangular shaped lot and is currently the Alliance Gas Station (see Figure 2 for the Site Plan). The existing Alliance Gas Station was built during the Sixties and is located on the corner of Hesperian Boulevard and West A Street in Hayward, California. The site is fully paved with concrete and asphalt. The site contains three 10,000 gallon underground fuel tanks. Three groundwater monitoring wells were noted on the black top and concrete areas (see Figure 2). The site is surrounded on four sides by two abandoned service station sites and businesses that are currently using or at one time used hydrocarbon products in their business.

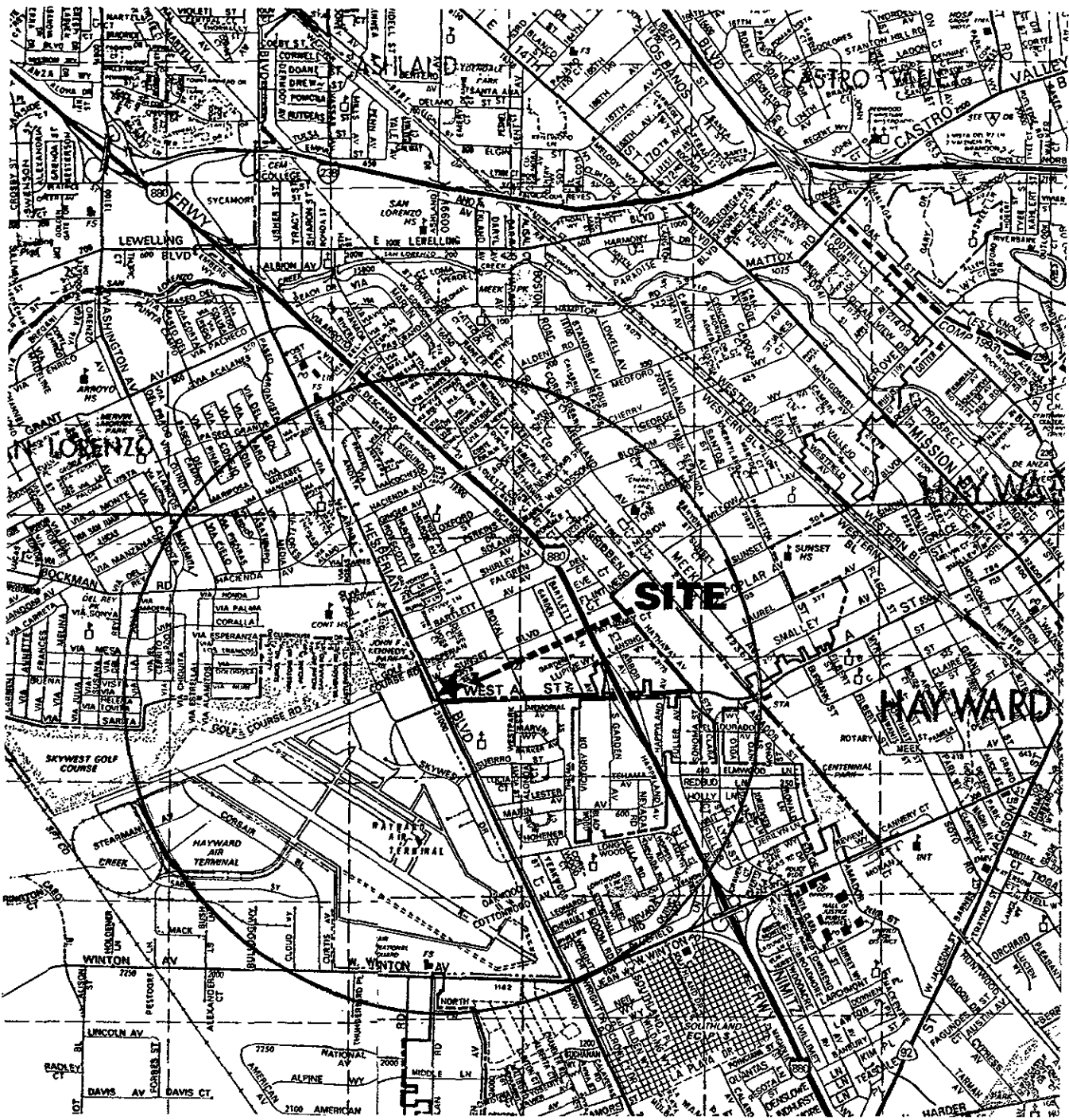
#### **2.1.3 SITE HISTORY:**

On March 19, 1991, Mr. Danny Chauhan, owner of the Alliance Service Station, received a letter from Alameda County requesting proof that the tank systems on the assessment site were not a contributing source of groundwater contamination for the area located at the corner of Hesperian Boulevard and West A Street.

On July 24, 1991, Mr. Chauhan received another letter requesting the same information as requested in the March 19, 1991, letter.

On September 23, 1991, Alameda County submitted a second notice of violation to Mr. Danny Chauhan. The letter requested the following information by October 5, 1991:

1. Precision tank test results for the leaded gasoline tank for 1990 and tank test results for all three tanks for 1989.
2. A written report of the investigation of inventory variations noted in excess of tolerance during the past three years.
3. A technical report describing Subsurface Investigation Plan. Include a timetable for implementation.

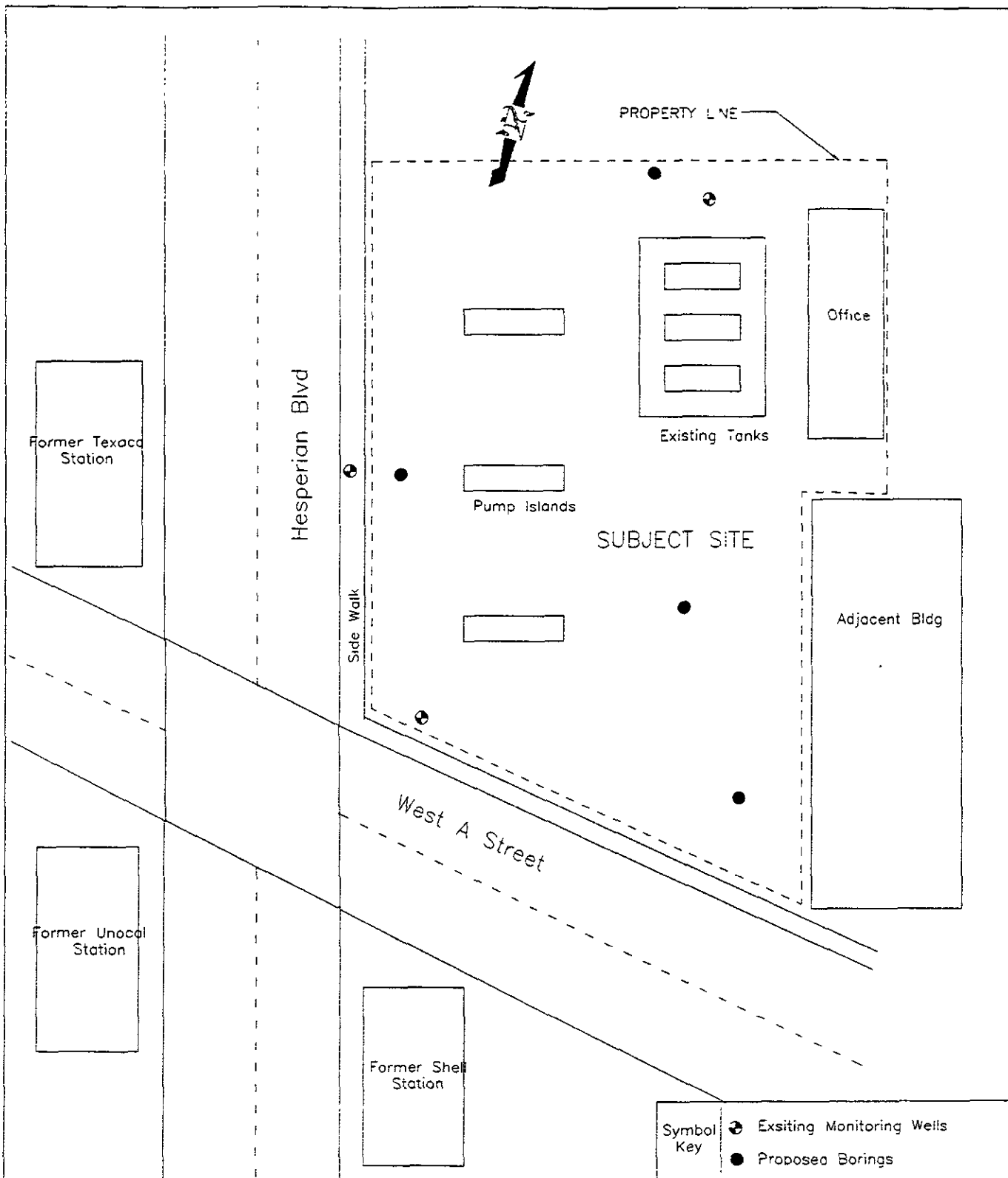

On January 2, 1992, Alameda County submitted a final notice of violation to Mr. Danny Chauhan.

On January 26, 1993, Alameda County submitted a letter to Mr. Chauhan requesting him to submit a Work Plan to investigate the vertical and lateral extent of the potential contamination at his site.

On August 9, 1993, Mr. Zane Miller, a consultant representing Mr. Chauhan, submitted a Drilling Permit Application to Zone 7 Water Agency, for placement of monitoring wells on site.

On August 24, 1993 Viking Drillers, Inc. drilled and placed three groundwater monitoring wells at the site. The wells were drilled to a depth of 25 feet. Groundwater was encountered at a depth of 18 feet. Nine soil samples were obtained and delivered on September 9, 1993, to Sequoia Analytical in Sacramento, for analysis of TPH-G and BTEX.

On September 28, 1993, Alameda County submitted a letter to Mr. Danny Chauhan requesting information on the site investigation work performed by Mr. Zane Miller.

On December 2, 1993, Alameda County submitted a letter to Mr. Danny Chauhan stating that they believed the assessment site was contributing to a regional groundwater contaminant plume consisting of separate and dissolved-phase hydrocarbons.

On January 7, 1994, The Alliance Gas Station retained the services of Certified Environmental Consulting, Inc. to perform a Preliminary Site Assessment (Phase I) and a Site Investigation (Phase II) on the subject site.

#### **2.1.4 NEIGHBORING SITES:**

The following streets and or properties are within 2,000 feet of the assessment property (see Figure 1). Streets include Hesperian Boulevard, West A Street, Skyway Drive, Sunset Boulevard, Bartlett Avenue, Royal Avenue, Garden Avenue, and Sueirro Street.

North: Weber Auto Supply, Airport Appliance, and Arco. The remaining areas to the North are mainly residential and contain several schools.

South: Shopping center containing the following businesses: Togos, Savers, Hancocks Fabrics, Baskin Robbins. Other businesses include The Executive Inn, Burger King, and The Plaza Market.

East: Mirandas Auto Repair, Goodwill Store, BP Service Station, Quality Tune-up/Smog Center, Auto Body Shop, Fred's Radiator Service, Jess and Cins Motorcycle, Bay City Auto Repair, Jim

Bavermeister Auto Service and Repair, and two abandoned service stations.

West: Vagabond Inn, Festival Cinemas, and The Hayward Air Terminal.

## 2.2 SITE PHYSICAL CHARACTERISTICS

### 2.2.1 TOPOGRAPHY AND SURFACE WATER HYDROLOGY

The assessment property is located within the flatlands of the East Bay Plain on the east side of the San Francisco Bay. The topography slopes gently to the west, from the East Bay hills towards the Bay, (approximately 2 miles west of the site). Surface water drains into the municipal storm systems.

### 2.2.2 GEOLOGY

The site rests on undifferentiated deposits consisting of marine clay, and sand with minor lenses of gravel underlying a thin cover of alluvium and slope wash. The deposits are of Quaternary age upper pleistocene to recent (QU). These are thick unconsolidated deposits with an average thickness exceeding 600 feet. Bedrock occurs at depths of between 468 and 732 feet.

The closest faults in the quadrangle are the Hayward Fault located approximately 1-3/4 miles to Northeast, the West Chabot Fault located approximately 2-1/4 miles to the Northeast, and the East Chabot Fault located approximately 2-3/4 miles to the Northeast. The Hayward Fault is considered to be the most threatening to the area. It is an active fault having displayed movement within the last 11,000 years. The East and West Chabot Faults are considered to be in-active.

### 2.2.3 HYDROGEOLOGY

The site rests within the East Bay Plain. The plain covers an area of approximately 114 square miles. Most of the groundwater is used for irrigation and industrial use, with very little of it pumped for domestic consumption. The groundwater reservoir is comprised of three main unconsolidated water bearing units: The Older Alluvium, the Younger Alluvium, and the Merritt Sand. The reservoir is greater than 1100 feet thick and occurs in unconfined and confined conditions.

The groundwater beneath the East Bay Plain has been seriously threatened by hundreds of documented toxic spills and leaks since 1984. The most serious threat to the groundwater reservoir occurs where the Younger Alluvium, and Merritt Sand outcrop and also along the recharge area of the Older Alluvium. Groundwater in the Older Alluvium has not yet been degraded by toxins.

Groundwater flow direction within the plain in general is from the Eastern part of the reservoir to the West, towards San Francisco Bay.

#### **2.2.4 ACTIVE FAULTING AND SEISMICITY:**

The assessment property is not located within the Alquist-Priolo Special Studies Zones Act, which was signed into California Law on December 22, 1972 (Hart, 1985). Under this Act, Special Studies Zones are delineated along known active faults. An active fault is one that has shown surface displacement within Holocene Time (approximately the last 11,000 years). The fault located nearest the assessment site is the Hayward Fault (approximately 1-3/4 miles Northwest), which is considered a historically (last 200 years) active fault. The West and East Chabot Faults, located approximately 2-1/4 and 2-3/4 miles to the Northeast respectively, are both considered to be in-active.

The entire San Francisco Bay Area is located within a region subject to a high level of seismic activity. Therefore, the assessment site will probably experience strong seismic shaking within its lifetime.

## **SECTION 3.0 - HISTORICAL SITE CONDITIONS**

### **3.1 TITLE HISTORY:**

A Chain of Title History Report was not ordered because of the availability of aerial photographs and knowledge of the activities which have occurred on the property since its commercial use from the present owner. The historical review presented in this report is in compliance with ASTM (American Society for Testing and Materials) Standard E.50.02.2.

### **3.2 INTERVIEWS:**

1. Mr. Kiran Khatri, Manager for Alliance Gas Station for several years, was asked what he knew about the general area. Mr. Khatri informed me that the intersection of Hesperian Boulevard and West A Street once contained a service station at each corner. The service stations were demolished and each had their underground tanks removed. Each of these abandoned sites are currently involved in site investigations. Of the three sites, only one contains a new building.
2. Ms Juliet Shin, Hazardous Materials Specialist, with the Alameda County Health Agency informed CEC that the assessment site is believed to be contributing to a regional groundwater contaminant plume consisting of separate- and dissolved-phase hydrocarbons.

### **3.3 AERIAL PHOTOGRAPH REVIEW:**

Aerial photographs of the assessment property dated 3-24-47, 5-3-57, 7-7-59, 5-2-69, 9-6-79, 6-21-83, 5-15-85, 3-30-88, and 4-20-92 were reviewed. All of the photographs were of sufficient quality to observe general activities, but have limited value in assessing specific details.

The assessment property was part of a farm during the 1940's. Most of the area within a one-half mile radius was comprised of small homes, orchards and large open fields. The Hayward Airfield was active during that time and a small creek was observed approximately one city block to the south of the assessment site. Development around the Hesperian Boulevard-West A Street intersection began to develop during the late 1950's, and was fully developed by 1979. A total of four service stations were built at this intersection starting in the mid 1960's with the Wickland Oil Station at the assessment site. The southeast corner service station followed in the late 1960's (Shell). The southwest corner service station (Unocal) followed at approximately the same time. The northwest service station (Texaco) was developed sometime during the mid to late 1970's. The Shell Station was demolished in 1984 followed by the Unocal Station sometime during the late 1980's to 1992. The Texaco Station was abandoned in 1992.

### 3.4 CITY CROSS INDEX DIRECTORY REVIEW

From interviews and on-site evidence, it is obvious that the site is a service station, therefore, the City Cross Index Directory was not reviewed.

### 3.5 SANBORN AND TOPOGRAPHIC MAP REVIEW:

#### Sanborn Map Review

Sanborn Maps are generated as a result of insurance company needs. Mapping began in 1867. These maps document the various businesses and uses in a given area so that risk may be determined for a particular site which needs insurance. They are very useful for determining potential environmental risk for a given site which may result from historical activities on the site or adjacent properties. The Sanborn Insurance Company periodically updates maps of areas with information about the potential for storage of hazardous materials on the site or storage tanks etc. If these maps are available on an area, they can provide valuable historical documentation and the potential for environmental contamination that might not be readily apparent today.

Sanborn Maps were requested from Vista Environmental for the period from 1911 to 1980. No Sanborn Maps were available for the assessment property.

## SECTION 4.0 - REGULATORY REVIEW

CEC performed the following tasks to evaluate the assessment site and neighboring properties for environmental compliance and potential risk from off-site hazardous material/waste releases:

- Vista Environmental provided a regulatory database review of non-compliance sites including a map identifying environmental risk sites within one mile of the assessment property. (See discussions below.)
- Upgradient site regulatory files were reviewed and are summarized below.

### A. Federal Data Base U.S. Environmental Protection Agency

1. **National Priority List (NPL)** is the list of the top priority facilities requiring remediation.

The National Priorities (Superfund) List (NPL) is EPA's database of uncontrolled or abandoned hazardous waste sites identified for priority remedial actions under the Superfund Program. A site, to be included on the NPL, must either meet or surpass a predetermined hazard ranking systems score, or be chosen as a state's top-priority site, or meet all three of the following criteria: (1) the US Department of Health and Human Services issues a health advisory recommending that people be removed from the site to avoid exposure; (2) EPA determines that the site represents a significant threat; and (3) EPA determines that remedial action is more cost-effective than removal action.

A search of the June, 1993 National Priorities List revealed no sites listed on this database within a one mile radius of the assessment property.

2. **CERCLIS Database**

Comprehensive Environmental Response Compensation and Liability Information System list is a compilation by EPA of the sites which EPA has investigated or is currently investigating for a release or threatened release of hazardous substances pursuant to the Comprehensive Environmental Response, Compensation and Liability Act of 1980 (Superfund Act).

A search of the June, 1993 CERCLIS Database List revealed one site listed within a one-mile radius of the assessment property. The site is located near the southwest limits of the one mile search radius, is down gradient, and should not affect the assessment site.

### 3. Consolidated Docket

The Consolidated Docket Enforcement System is a compilation of civil judicial enforcement actions filed by the Department of Justice on behalf of EPA against violators of Federal Environmental Statutes.

A search of the November, 1993 Consolidated Docket Enforcement Database revealed no cases in the National Docket System involving facilities located within the stated zip code area.

### 4. Federal Superfund Liens (LIENS) Database

The Federal Superfund Liens Database was prepared by the U.S. EPA as a listing of filed notices of Superfund liens. These liens are filed by the U.S. EPA against real property to recover clean up, response and any other expenditure made by the U.S. EPA under the CERCLA Program. It is updated quarterly. Because these liens are "statutory Liens" they arise when the agency spends money on a site or when notification of potential liability is received by the owner of the property. EPA maintains that these liens can arise without filing, however, and they suggest checking CERCLIS sites for lien status.

A search of the September, 1991 (LIENS) Database revealed no sites within a one-mile radius of the assessment property.

### 5. California State Water Regional Control Board, Office of Underground Storage Tanks

This office maintains an inventory of registered underground storage tanks. This inventory is a database which contains information from the: Underground Storage Tank Registrations Database of June 1993; UST June 1993, and Orange County Underground Storage Tank Facilities of December 1992.

A search of the updated June, 1993 List revealed the following four sites within a 1/4 mile radius of the assessment property:

**1. List of Landfills**

No landfills were identified within one mile of the assessment site.

**2. Solid Waste (SWIS)**

No solid waste facilities were identified in the March, 1993 (SWIS) database that were within one mile of the assessment site.

**3. Hazardous Waste Information System (HWIS)**

The California Department of Health Services, Toxic Substances Control Division identified and tracks hazardous waste from the point of generation to the point of disposal. The HWIS database is a compilation of reporting facilities that generate, store, transport, treat or dispose of hazardous waste in California.

A search of the December, 1992 (HWIS) Database revealed two (2) sites within a 1/4 mile radius of the assessment property. They are as follows:

4. **Hazardous Waste and Substances Sites List (Cortese List)**

The California Governor's Office of Planning and Research annually publishes a listing of potential and confirmed hazardous waste sites throughout California. This database currently contains approximately 6,000 entries in the State of California. This list is based on input from DHS1, DHS2, DHS3, DHS5, WRCB and CWMB.

**5. Cal-Sites (AWP)**

The Annual Work Plan (AWP) contains a listing of all verified hazardous waste sites that are or will be targeted for abatement by the California Environmental Protection Agency. Hazardous waste sites are discovered by the California EPA, another government agency, such as a local health department, a Regional Water Quality Control Board, a responsible party or concerned citizen. The California EPA adds the new sites to this database after they are verified and the "Preliminary Assessment, Site Investigation and Hazard Ranking System" processes are completed. This database has been incorporated into the CAL-Sites Database.

A search of the July, 1993 (AWP) database disclosed no sites within one mile of the assessment property.

**6. Leaking Underground Storage Tanks (LUST)**

Leaking Underground Storage Tank Facility (LUST) is the California Regional Water Quality Control Offices inventory of known leaking underground storage tank incidents located in the State.

**7. Border Zone Property Act Sites (Deed Restrictions)**

A database of the properties "on or within 2,000 feet of significant disposal of hazardous waste" which the CAL-EPA has restricted. Restrictions may include "activities on, over or under the land, including, but not limited to, a prohibition against building, filling, grading, excavating, or mining" without the written permission of DTSC. This list compiled by the DTSC of properties subject to deed restrictions is used to notify various building and planning departments in local jurisdictions.

A search of the July, 1993 Hazardous Waste Property/Border Zone Property Database revealed that the property is not a listed site and no listed sites are within a one mile radius of the assessment property.

**8. CAL-SITES (ASPIS)**

Cal-Sites (ASPIS) database is created by the California Department of Toxic Substance Control (TSC) and contains a listing of potential and known hazardous waste sites and the current Rural Site Evaluation Program. TSC staff have interviewed officials from county health agencies, local fire departments, county agricultural commissioners, and other local agencies that could reasonably be expected to have information regarding potential waste sites. The records of the Regional Water Quality Control Boards, Department of Fish and Game and other state environmental regulatory agencies are also researched. TSC staff also review historical land use data sources to generate lists of potential sites.

A search of the July, 1993 Cal-Sites (ASPIS) Database revealed that the property is not an ASPIS site. Twenty-two sites are located within a one mile radius of the assessment property.

The following two sites are upgradient of the assessment site:

**9. Solid Waste Information System (SWIS)**

The California Integrated Waste Management Board maintains an inventory list of both open as well as closed and inactive solid waste disposal facilities and transfer stations. These locations of disposal facilities are gained from permit applications and from local enforcement agencies.

The March, 1993 (SWIS) Database revealed that the property is not a SWIS site and no SWIS sites are within a one mile radius of the assessment property.

**10. Sara Title III - Community Right-To-Know**

Sara Title III is often used as shorthand for emergency or accidental spill reports, such as the EPA ERNS Database. Community Right-To-Know often is used to refer to corporate reporting requirements for chemicals and other hazards maintained at plant sites. In fact, SARA Title III and Community Right-To-Know are one in the same. SARA Title III refers to a section of the Superfund amendments that were passed in 1986 and Emergency Planning and Community Right-To-Know is the more descriptive name for many of those provisions.

In general, the Emergency Planning and Community Right-To-Know Act (EPCRA) was passed in response to the release of methyl isocyanide from a chemical plant in Bhopal India in 1984. The general idea of EPCRA was to provide communities in this country with information about businesses that maintain or work with potentially toxic materials and to establish emergency planning procedures at the local level to deal with accidental releases of these materials. The basis of the laws is a number of reporting requirements imposed on businesses that handle toxic materials.

Eighteen sites were listed on the ERNS Database in the same zip code as the assessment property. Six sites were located within the one-mile search radius. None of the listed sites appear to have impacted the subject property.

## SECTION 5.0 DISCUSSION/ENVIRONMENTAL RISK OBSERVATIONS

### 5.1 KNOWN SPILLS, LEAKS OR ON SITE DISPOSAL:

*Observations/Findings:* On December 2, 1993, Ms. Juliet Shin of the Alameda County Department of Environmental Health sent a letter to the owner of the assessment site informing him that her department had reason to believe that the site may be contributing to a regional groundwater contaminant plume. A Phase II Site Investigation is currently being proposed at the assessment site.

### 5.2 HAZARDOUS MATERIAL STORAGE, USE OR WASTE DISPOSAL:

The term hazardous substances refers to a wide range of chemical, radioactive, and biological substances or materials. These substances pose health and safety risks due to specific characteristics related to the material, such as flammability, combustibility, corrosivity, toxicity, reactivity, or explosivity. Hazardous materials have a potential to cause contamination to a property or its surroundings should they be released by a spill or fire into the environment. In addition, the improper disposal of a hazardous substances can result in contamination of soil, groundwater, or surface water at the disposal location.

The discharge of contaminated water or hazardous materials to storm drains is also regulated by the NPDES process. Oil water separators could be required if contamination is flooding the storm drain.

*Observations/Findings:* There are currently three underground fuel tanks containing gasoline on the assessment property. As discussed above, the site is a gas station and a Phase II Site Investigation is currently being proposed.

### 5.3 POLYCHLORINATED BIPHENYLS (PCB'S):

PCBs have been primarily used in electrical equipment but were also included in hydraulic systems and oil-filled heat transfer systems. PCBs are deleterious because once released into the environment, they do not break down into harmless chemical substances. Animal studies also indicate that PCBs may be carcinogenic and teratogenic (fetus damaging), and the EPA has determined that PCB contamination may pose a public health concern. However, to date, there have been no documented cases of human cancer caused by exposure to PCB's.

*Observations/Findings:* There did not appear to be any sources of PCB's on the assessment property. ~~However, hydraulic lifts were present on the site at one time. Hydraulic fluids used for lubricating lifts have been known to contain PCB's.~~ Therefore, there may be a potential for PCB's on the site.

#### 5.4 ASBESTOS:

Asbestos is a naturally occurring mineral used since ancient times for a variety of purposes. It occurs as a strong fiber with characteristics for heat insulation, sound insulation, and fire resistance. Over 3,000 different uses have been developed for asbestos including building materials, which have been extensively used in the United States since the mid-1900's.

As the use of asbestos in building materials increased, so did lung diseases among those who worked with it. These diseases include asbestosis (a scarring of the lung), lung cancer, and mesothelioma (a cancer of the lung lining). Typically, these diseases take between 10 and 40 years to appear after exposure.

*Observations/Findings:* The existing structure was built during the 1960's and therefore has a potential for the presence of asbestos-containing materials. An Asbestos survey was not performed as part of this Phase I Investigation.

#### 5.5 RADON:

Radon is the immediate daughter product of the radioactive decay of radium-226, but the ultimate source of radon is the decay of uranium. Radon concentrations in soil gas and groundwater generally show a direct correlation to the uranium content of bedrock. The underlying sediments in the area of the assessment property contain little or no uranium, radium-226, and radon-222 (Michael and Jordan, 1977). Consequently, structures in Alameda County have a very low risk of containing elevated radon levels. This data, however, should not be used to predict the radon concentrations in a particular structure on the assessment site.

Radon is a naturally occurring radioactive gas. It cannot be seen, smelled, or tasted. Although radon gas itself does not represent a high irradiation hazard, it releases radioactive alpha particles as it decays which can cause lung cancer if inhaled. The principal danger associated with alpha emitters is internal irradiation following entry of the isotope into the body. Airborne dust aggravates the problem, since radionuclides, such as radon or uranium, readily attach to dust particles.

Radon gets into indoor air from degassing of drinking water used in showers, dishwashers, clothes washers, toilets, etc. (Cothorn, 1988) and from direct gas flux into buildings from

underlying soil and rock (Hall and others, 1988). Indoor levels of radon depend on building construction and the concentration of radon in the underlying soil and groundwater. It is estimated that the amount of radon from soil gas, the primary radon source, is about an order of magnitude greater than radon from groundwater degassing. In open air, radon is usually diluted to such low concentrations that it does not become a health hazard. However, radon can accumulate in enclosed spaces (e.g., homes, schools, or offices) to levels that can pose risks to human health. The level of radon in water required to raise the level of radon in a building to 4 pCi/l has never been established, particularly because variables, such as architecture, degassing efficiency, and ventilation, are difficult to evaluate. Some workers, however, believe that radon levels of 100,000 Pci/l or more in groundwater are capable of contributing to excessive radon levels (Hall and others, 1988).

*Observations/Findings:* The property is not situated on rocks that are known to be significant generators of radon, does not contain a basement, and appears to be well ventilated. Therefore, CEC does not recommend that a Radon Survey be initiated.

#### **5.6 LEAD (WATER WELLS/PAINT):**

Lead is a toxic element. It is present in the environment because of its frequent use as an additive in paints, gasoline and a number of other everyday products. Exposure to high levels can lead to brain damage, kidney malfunctions, unintentional abortions and even death. Lower levels can cause stunted growth, mental retardation and a variety of other problems in children and fetuses.

Lead exposure also occurs from drinking water that is supplied through lead or lead-soldered galvanized pipe. Children frequently ingest lead by eating flaking paint in older homes. This is a problem occurring generally in homes built before 1978, when the Consumer Products Safety Commission banned the sale of paint with more than 0.06% lead by weight.

The Lead-based Paint Poisoning Prevention Act (LPPPA) requires the Department of Housing and Urban Development to establish procedures to eliminate lead-based paint hazards in HUD-owned, insured and assisted housing constructed or substantially rehabilitated before 1978.

*Observations/Findings:* The existing structure is of late construction and the potential for lead based paint is probable. An assessment of plumbing pipelines for lead brazed joints and paint samples were not performed as part of the Phase I Scope of Work.

#### **5.7 WELLS:**

*Observations/Findings:* There are currently three groundwater monitoring wells on the assessment property.

## 5.8 WATER OR STORM DRAIN DISCHARGES:

*Observations/Findings:* There are no present activities on the property that indicate illegal discharges. The facility does not require an NPDES permit for surface water discharge into storm drains. The assessment property did at one time contain a service garage. Therefore, the site may have discharged solvents/oil into the storm drains or sanitary drains prior to ownership by the present owner.

## 5.9 DISPOSAL SITES, LANDFILLS, DUMPS AND SURFACE IMPOUNDMENTS:

Land disposal of hazardous substances may occur at open dumps, at surface impoundments or lagoons, at underground injection wells, or at landfills. Several hazards are associated with land disposal methods. For example, when a hazardous substance is disposed of in one of these land disposal sites, a potential exists for soil, surface water, and groundwater contamination. This contamination can pose a risk to the environment and neighboring population (particularly if the groundwater or surface water is used for drinking water). Landfills and dumps that are used to dispose of organic materials (e.g., municipal waste, sewage sludge, vegetation) can also generate methane gas.

*Observations/Findings:* There were no landfills, dumps or surface impoundments identified within one mile of this site according to the Vista Environmental Database Report.

## 5.10 ABOVE & UNDERGROUND STORAGE TANKS OR PIPELINES:

Leaking storage tanks present a hazard to the environment through hazardous material contamination and movement through the soil and groundwater. Regulations include pipelines leading from these tanks.

### A. Underground Storage Tanks

Leaking underground storage tanks (USTs) used to store petroleum products or other hazardous substances present a hazard to the environment and surrounding properties, primarily contamination of soil and groundwater. By definition, USTs are tanks, including associated piping, that are more than 10 percent below ground. Migration of product into utility conduits (i.e., underground pipes) or basements of nearby structures can also be a hazard. RCRA regulations contain requirements for notifying EPA (or an authorized state agency) of a UST's presence, installing new USTs, upgrading old USTs, testing for leaking USTs, and closing inactive USTs.

### B. Aboveground Storage Tanks

The hazards posed by aboveground storage tanks (ASTs) are similar to those of underground storage tanks (USTs). A leaking AST used to store a petroleum product or other hazardous substance presents a risk of contaminating surface

soils and surface waters (i.e., streams, ponds, lakes, rivers, oceans) as well as groundwater if a large leak or spill is not rapidly detected and cleaned up. An AST also poses a fire/explosion hazard if it contains flammable, combustible, or reactive materials. EPA's regulations require certain facilities with ASTs to establish emergency response procedures that would aid in rapid response to contain and clean up a spill or leak.

*Observations/Findings:* Three 10,000 gallon underground fuel tanks are currently buried on site. These fuel tanks are currently being investigated for possible contribution to a regional groundwater contaminant plume. Prior to ownership by the present owner, the assessment site contained a service garage and may have contained an underground waste oil tank and hydraulic lifts which may have leaked.

#### **5.11 RADIOLOGICAL HAZARDS (OTHER THAN RADON)**

*Observations/Findings:* There were no radiological sources noted on site.

#### **5.12 PESTICIDES:**

Pesticides include insecticides, herbicides, rodenticides, fungicides, disinfectants, and plant growth regulators. Many of the newer pesticides chemically break down a few days after application, however, older applications, such as DDT and Toxaphene, do not easily break down and will persist as soil or groundwater contaminates for many years.

*Observations/Findings:* The potential for pesticide residues on the site is very low.

#### **5.13 AIR EMISSIONS:**

*Observations/Findings:* There appear to be no significant risks to the air environment from activities on the assessment site.

#### **5.14 WATER SUPPLIES:**

*Observations/Findings:* Water in the area of the assessment site is supplied by East Bay MUDD.

#### **5.15 PERMITS:**

*Observations/Findings:* An NPDES Stormwater Runoff Permit may be required, if future grading of the site is anticipated.

#### **5.16 SAFETY:**

*Observations/Findings:* There did not appear to be any significant safety issues associated with the assessment property.

## SECTION 6.0 - SPECIAL OR CULTURAL RESOURCES

### 6.1 FLOOD PLAIN MANAGEMENT PLANS:

The U.S. Army Corps of Engineers may also require permits for activities within the open water areas under the Rivers and Harbors Act of 1899 and the Clean Water Act. Communities that wish to participate in the National Flood Insurance Program, as administered by the Federal Emergency Management Agency, must implement and enforce a floodplain management plan that meets minimum standards. These flood plain management plans may place restrictions on land development activities.

*Observations/Findings:* According to the City of Hayward Department of Public Works, the assessment property falls within Flood Zone AO, which is an area within the 100 year floodplain. According to Mr. Perry Merafta, Alameda County, the site is subject to shallow flooding.

### 6.2 SOLE SOURCE AQUIFERS:

In 1986, amendments to the Safe Drinking Water Act (SDWA) were adopted which included the Sole Source Aquifer Demonstration Program. A sole or principal source aquifer is an aquifer that supplies 50 percent or more of the drinking water for an area. States and local jurisdictions often impose stringent development and land use restrictions to areas designated as sole source aquifers.

*Observations/Findings:* The assessment property does not fall under "Sole Source Aquifer" Regulations.

### 6.3 HISTORICAL SIGNIFICANCE/ARCHAEOLOGICAL RESOURCES:

Certain significant types of historic resources are protected from activity that may damage their historic value. This damage may occur in obvious ways, such as tearing down an important old building, but also in less obvious ways, such as removing an object so that its relationship to other parts of the historic location is lost, though the object itself is not actually damaged.

Preserving historic properties is regulated federally under the Antiquities Act of 1906, the Historic Sites Act of 1935, and the National Historic Preservation Act of 1966, as amended. These last two laws made the Secretary of the Interior responsible for maintaining a list of properties that are significant in American history, architecture, archaeology, engineering, and culture; and are worthy of preservation.

Archaeological resources are considered historic property and, as such, may be protected as important reflections of our American heritage under the Antiquities Act of 1906, the Historic Sites Act of 1935, and the National Historic Preservation Act of 1966, as amended. These latter two laws made the Secretary of the Interior responsible for maintaining a list of properties that

are significant in American history, architecture, archaeology, engineering, and culture, and are worthy of preservation. This list is the National Register of Historic Places, and is maintained and expanded by the National Park Service on behalf of the Secretary of the Interior.

*Observations/Findings:* The National Register of Historic Places which is maintained by the National Park Services and the records maintained by the State Department of California were reviewed. There are no known historical buildings or archaeological resources either on or adjacent to this site, or listed within the general area.

#### **6.4 COASTAL DUNES AND BEACHES:**

Coastal dunes and beaches are low-lying strips of land that may be found along the ocean and Great Lakes coastlines.

Coastal dunes and beaches are protected by several programs at the Federal, state, and local levels. The Coastal Zone Management Act requires the development and approval of state coastal zone management plans, which may place restrictions on coastal dune and beach activities. The program is administered by the National Oceanic and Atmospheric Administration or by approved states.

*Observations/Findings:* There are no coastal barriers or resource areas on or near the assessment property. The assessment site is not on or near an area containing "Coastal Dunes".

#### **6.5 NATURAL LANDMARKS**

These sites are often listed in the National Registry of Natural Landmarks.

*Observations/Findings:* There are no natural landmarks on or near the assessment property.

#### **6.6 WILD AND SCENIC RIVERS:**

Wild and scenic rivers are protected under the Wildlife and Scenic rivers Act. The U.S. Department of Interior is responsible for maintaining the National Wild and Scenic River System inventory.

Restrictions under the Act apply mostly to Federal Agencies; however, private projects that require Federal agency approvals or permits may also be affected including waste water discharge and wetlands permits. Prior to issuing any approvals or permits to a private project, Federal agencies must consider direct or indirect impacts to wild and scenic rivers and can deny permits on the basis of impacts to the rivers.

*Observations/Findings:* The assessment site is not located on or near an area where development could be impacted by these regulations.

## 6.7 RECREATIONAL AREAS:

Recreational areas include national and state parks, forests, and wilderness areas.

These areas are maintained and operated by designated Federal and state agencies. The National Park Service of the U.S. Department of Interior (USDI) has jurisdiction over the National Park System. National forests are managed by the U.S. Department of Agriculture's Forest Service. Both of these agencies and the Bureau of Land Management of USDI manage the land within the National Wilderness System.

*Observations/Findings:* The assessment site is not located near any land regulated by these agencies.

## SECTION 7.0 - CONCLUSIONS

Based on the current information accumulated during our investigation of the assessment property located at 20450 Hesperian Boulevard, Hayward, California, CEC can conclude the following information:

- The current structure was constructed before 1980, and therefore has a medium to high potential for asbestos and lead to be present in the existing structure.
- The assessment property was a service station as far back as the mid 1960's (See 3.3 Aerial Photograph Review). The property at one time contained a service garage which was converted to the present convenience store and office. The three existing fuel tanks on the site may be contributing to a regional groundwater contaminant plume, as discussed in the December 2, 1993 letter by Juliet Shin of the Alameda County Health Agency. The entire intersection contained a service station at each corner and each was subject to a Phase II Site Investigation. The assessment site rests downgradient of several service stations located on West A Street and several auto repair services. These businesses could be potential sources to the regional groundwater contaminant plume. The Federal and State databases used for this investigation indicate that there is a potential for soil and groundwater hydrocarbon contamination to be present at the subject site.

## SECTION 8.0 - RECOMMENDATIONS

The following recommendations are based on CEC's site visit, review of the current Federal and State database information, and current regulations:

- CEC recommends that a Phase II Soil and Groundwater Investigation be conducted at the assessment site to determine if hydrocarbon particulates are present.

This would be in compliance with Alameda County's request for a Site Investigation on your property.

The scope of services performed in execution of this investigation may not be appropriate to satisfy the needs of other users, and any use or reuse of this document or the findings, conclusions, or recommendations presented herein is at the sole risk of said user. It should also be noted that some assumptions were drawn from other engineering reports for which CEC cannot be held responsible for with regard to the quality or accuracy of their information.

It should be recognized that this study was not intended to be a definitive investigation of contamination at the subject property. 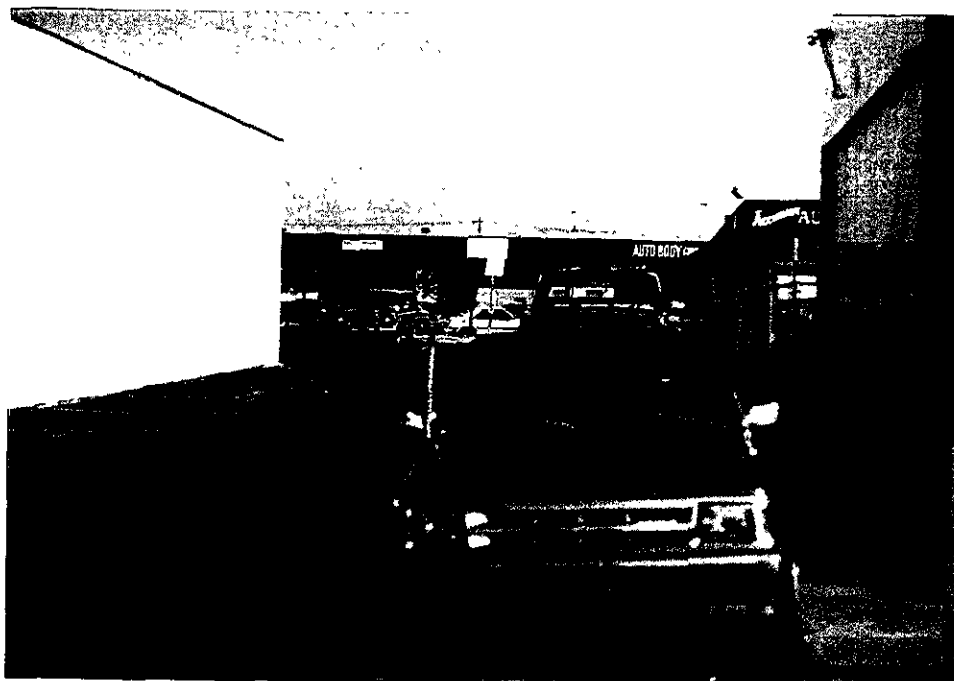

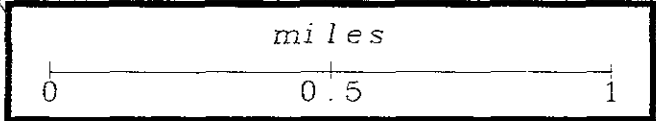
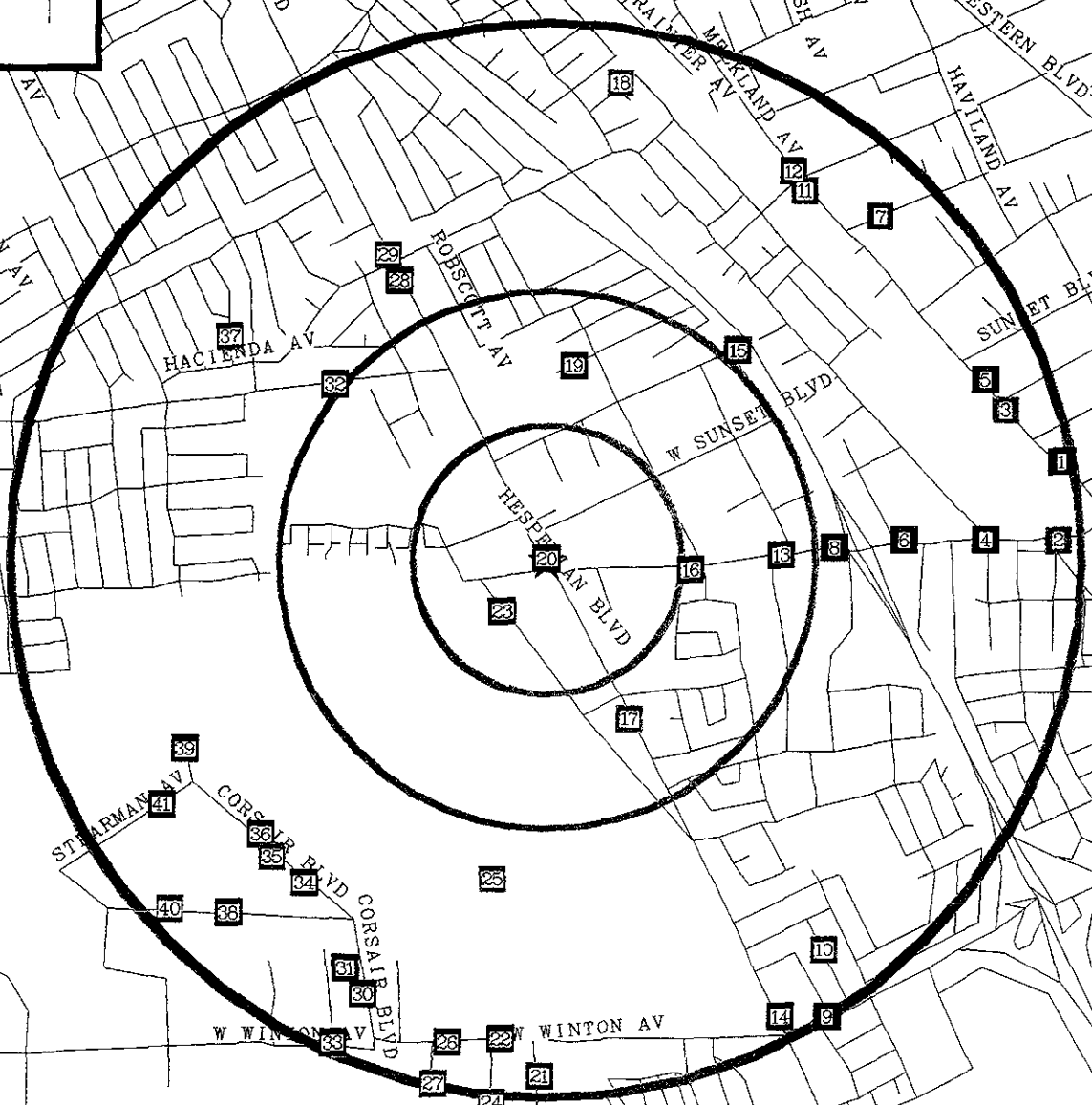

**BORDER ZONE PROPERTY ACT SITES**

In accordance with Assembly Bill 816, and the Hazardous Waste Property/Border Zone Property Law (Health & Safety Code 25220), the CAL-EPA, Toxic Substances Control Program (TSCP) enters into voluntary deed restriction agreements with owners of property who propose building residences, schools, hospitals or day care centers on property that is "on or within 2,000 feet of a significant disposal of hazardous waste". Restrictions may include "activities on, over, or under the land, including, but not limited to, a prohibition against building, filling, grading, excavating, or mining" without the written permission of the TSCP.

This bill requires the TSCP to "notify the planning and building department of each city, county, or regional council of governments when a land use restriction has been recorded, and would require the planning and building department to enforce the restriction," although the TSCP has compiled a list of properties subject to environmental deed restrictions which is used to notify various building and planning departments in local jurisdictions.

Developed under Section 25359.6 of the Health and Safety Code, the California EPA Toxic Substance Control Program (TSCP) maintains a listing of potential and known hazardous waste sites. TSCP staff have interviewed officials from county health agencies, local fire departments, county agricultural commissioners, and other local agencies that could reasonably be expected to have information regarding potential waste sites. The Regional Water Quality Control Boards, Department of Fish and Game and other state environmental regulatory agencies' TSCP staffs also review historical land use data sources to generate lists of potentially contaminated sites.

This database was formerly known as the Abandoned Site Program Information System, but was integrated into the CAL-SITES database in 1991. Information concerning most of these sites should be considered preliminary although most confirmed sites from this database are merged into the AWP once they have been hazard ranked. This database currently contains more than 26,000 sites in the State of California.

Status codes for some regions are not available directly from the nine boards. For those regions VISTA supplements the region's status codes with state LUSTIS status codes. Information from LUSTIS is placed in parentheses and has been updated to May, 1993.
