Hi Sandra,

I can't speak for James, but from Environmental Health's view point, no needed paperwork appears needed. In regards to land use, the property would need to remain a service station to avoid a revisit of the environmental case. It would not be able to convert to another commercial use. A conversion from service station (which is commercial) to another commercial (non-service station) use would need a reevaluation. Hope this helps,

The report indicates the wells were destroyed. Destruction may or may not have been conducted under permit due to the lack of a statement or discussion in the report, but has been uploaded to our case files and is available as a PDF on the web at the address below my signature below.

I do not recall the reason for determining the status of the wells, but note that the 1994 closure requires review of the site with any land use change.
