

6/3/91 Called to leave message with Judy

Peters. I received a call last week from E+E. They've received a work assignment from EPA regarding ANCC. It's apparently listed on CERCLIS. They will be on-site May 13, 14, 15, and invited me out to check out what they were doing.
