Dear Mr. Hothem:

On August 20, 1993 I was called out to the above listed facility by Tom Tuley of our Vector Services Control District who observed improper handling of hazardous waste containers by some of your employees. An inspection of the building with Tom and Bill Whalen of your company revealed that the previous tenant Hoyt Container left hundreds of 55 gallon and smaller empty containers that were formerly being cleaned and recycled. Many of these containers had hazardous materials labels on them. Since some of them were not completely empty, they will have to be disposed of as hazardous waste as per Section 66261.7 of Title 22 of the California Code of Regulations. You need to have someone qualified in hazardous waste training inventory these containers and properly dispose or recycle them at this time.

In addition, there were several unlabeled 55 gallon drums that contained various unknown liquids. The contents of these drums will have to be characterized by a certified laboratory to determine whether they are hazardous or not before being properly disposed. If found hazardous, the drums and their contents will have to be removed by a licensed hazardous waste hauler for proper disposal with copies of the manifests sent to this office.

Please submit a plan of correction to this department within ten days of the receipt of this letter. This plan must include, but shall not be limited to:

- 1. Name of certified laboratory that will perform analysis on unknown waste
- 2. Name of licensed hazardous waste hauler
- 3. Location of approved disposal site
- 4. Estimated time schedule for completion of the clean-up.

Dear Ms. Giese:

We have received SCS Engineers report dated, January 9, 1989, File No. 388038.00, in regards to the above facility. In the report, the north wall of the underground tank pit was found to be contaminated with 7,300 ppm (gasoline). For contamination greater than 100 ppm, Regional Water Quality Control Board guidelines requires the installation of a monitoring well within ten feet of the source of the contamination and down gradient.

Please submit to us, within 30 thirty days of the receipt of this letter, your proposed location for a monitoring well.
