The following comments are to be considered:

- It is clear that the elevated volatile hydrocarbon concentrations (as high as 270 ppm TPHd in soil and 1,900 ppb TPHd in a groundwater sample) at the above site requires a soil and groundwater investigation.
- You were told of this requirement in a letter dated March 26, 1993 from this office.
- In a meeting with Dennis Byrne and Jennifer Eberle of this office in June of 1993 you were also told of the requirement to conduct an investigation.
- 4. Apparently the last contact with this office was a phone call you had in August of 1993. Since that time there has been no action on your part to resolve this matter.

On Union St. 2-6,000 gallon tanks of (presumed stoddard solvent) were removed without sampling or witnesses in June of 1989. 1 6,500 gallon diesel tank was also removed from that area in August of 1989. 3 tanks (500, 2,000, and 1,000 gallon stoddard solvent were removed from a 28th St. area in May of 1990. The 28th St. area did not have significant contamination.

As you know, a number of underground storage tanks (USTs) were removed from the above-referenced site in 1989. A 6,500-gallon solvent UST was removed by Bob Simmons of Super Structures on 8/15/89, according to a "Soil Sampling Report" prepared by Kaprealian Engineering, Inc. (KEI), dated 9/8/89. Soil sampled from the UST excavation contained up to 270 ppm TPH-diesel. Water sampled from the UST excavation contained 1,900 ppb TPH-diesel.

Two other USTs were apparently illegally removed prior to the 8/15/89 UST removal. No tank removal application(s) are on file for the removal of these two USTs. There is further hearsay that two or three additional USTs were subsequently illegally removed from the sidewalk adjacent to 28th St. This makes a total of 5 or 6 USTs removed, apparently only one of which was legally removed. No field inspection reports or analytical results are on file for the removal of these 4 or 5 USTs. During a telephone conversation today between myself and Bob Simmons, who currently is an independent contractor, he indicated that he did not have any records of tank removal(s). Please submit documentation of the removal of these USTs within 45 days or by May 11, 1993. (We already have copies of hazardous waste manifests for the disposal of 3 stoddard solvent USTs.)

Due to the concentrations of contaminants detected during the UST removal on 8/15/89, a subsurface investigation is warranted to determine the possible impact to groundwater. This investigation must include the lateral and vertical delineation of soil and groundwater contamination.

Therefore, we request a workplan or proposal for a soil andgroundwater investigation, submitted under cover letter from yourself, and prepared by a recognized professional as outlined below. Please submit this workplan within 45 days or by May 11, 1993. This workplan should include analyses for chlorinated constituents because PCE was apparently stored in the USTs, according to a letter from the Alameda County District Attorney's Office to the Adult Probation Department dated 1/17/90.

This office has received a facsimile transmission from Superstructures Incorporated concerning proposed locations for the installation of groundwater monitoring wells at the site listed above. This letter is to confirm that the well placement locations proposed for this site are acceptable to this office.

The three wells will be used to determine groundwater flow direction. Once this is accomplished, the well oriented in a downgradient direction will be designated as the monitoring well and it will require sampling on a quarterly basis for a minimum of one year.
