



LANDOWNER NOTIFICATION AND PARTICIPATION REQUIREMENTS

Dear Mr. Lonacker:

This letter is to inform you of new legislative requirements pertaining to cleanup and closure of sites where an unauthorized release of hazardous substance, including petroleum, has occurred from an underground storage tank (UST). Section 25297.15(a) of Ch. 6.7 of the Health & Safety Code requires the primary or active responsible party to notify all current record owners of fee title to the site of: 1) a site cleanup proposal, 2) a site closure proposal, 3) a local agency intention to make a determination that no further action is required, and 4) a local agency intention to issue a closure letter. Section 25297.15(b) requires the local agency to take all reasonable steps to accommodate responsible landowners' participation in the cleanup or site closure process and to consider their input and recommendations.

For purposes of implementing these sections, you have been identified as the primary or active responsible party. Please provide to this agency, within twenty (20) calendar days of receipt of this notice, a complete mailing list of all current record owners of fee title to the site. You may use the enclosed "list of landowners" form (sample letter 2) as a template to comply with this requirement. If the list of current record owners of fee title to the site changes, you must notify the local agency of the change within 20 calendar days from when you are notified of the change.

If you are the sole landowner, please indicate that on the landowner list form. The following notice requirements do not apply to responsible parties who are the sole landowner for the site.

- 2) consider a site closure proposal
- 3) make a determination that no further action is required
- 4) issue a closure letter

You may use the enclosed "notice of proposed action" form (sample letter 3) as a template to comply with this requirement. Before approving a cleanup proposal or site closure proposal, determining that no further action is required, or issuing a closure letter, the local agency will take all reasonable steps necessary to accommodate responsible landowner participation in the cleanup and site closure process and will consider all input and recommendations from any responsible landowner.

After reviewing your file for closure with Madhulla Logan, our office Risk Assessor, this department decided that the more data is needed to verify the extent of contamination. There is only one monitoring well on-site, and the levels of MTBE has increased since quarterly monitoring commenced in June 1996. A minimum of two hydropunch grab water samples must be taken in the verified downgradient direction, and tested for TPH(G), Benzene, Toluene, ethylbenzene, Xylenes and MTBE. As you know, two 3,000-gallon and one 4,000-gallon gasoline Underground Storage Tanks (USTs) were removed from this site on 12/20/95. Soils sampled from the excavation indicated concentrations as high as 1,600 ppm Total Petroleum Hydrocarbons as gasoline (TPH-g), and 4 ppm benzene. The tank pit was overexcavated on 12/29/95, and resampled. Sample results indicated maximum concentrations of 400 ppm TPH-g and 3.1 ppm benzene.

Much discussion has ensued between us, and most recently via conference call with Comm Air's attorney, Carl Bailey, on 1/9/96. This letter will hopefully clarify these discussions.

At this point, you have an open excavation. You may choose to 1) continue to overexcavate the tank pit, and resample the two "hotspots," or 2) stop overexcavating the tank pit, backfill with either a) clean, imported fill OR b) aerated stockpiled soil (from the stockpile(s) designated Comp 1,A,B,C,D and Comp 2,A,B,C,D) that has been resampled at a rate of 1 discrete sample per 20 yd3, and found to contain no benzene. The TPH concentrations should be <10 ppm when benzene is ND. Toluene, ethylbenzene, and xylene concentrations should also be less than the MCL drinking water standards (100 ppb (action level), 680 ppb, 1,750 ppb, respectively) when benzene is ND. Please note that soil from the stockpiles designated STN-1, STN-2, and ST-M is acceptable for reuse at this time without aeration. Please contact the Air Quality Management District (AQMD) at 415-749-4900 or 4990 for permission and/or permits to aerate the soil.

You are also requested to perform a Soil and Water Investigation (SWI), as per Sect. 2724 of Chapter 16, Division 3, Title 23, California Code of Regulations. As discussed on the phone, you may install one monitoring well instead of the standard three. The rationale for this is data from a neighboring site, known as the former Carnation site, located at 1310-14th St. This site has numerous wells which have been sampled and monitored for a number of years, indicating a consistent N-NW groundwater flow direction at a rather flat gradient. Therefore, your well should be located within 10' in the N-NW direction from your tank excavation, to monitor any releases from the contaminated soil left in place in your tank excavation. Installation of another well is strongly recommended in the presumed upgradient direction (S-SE from the tank pit) in order to determine if there are any releases from the upgradient direction. Please note that if your downgradient well exhibits significant groundwater contamination, and you attribute it to an

upgradient source other than your tank excavation, then you may be requested to install an upgradient well(s) to demonstrate this is the case. Please submit a workplan for a SWI within 45 days, or by February 24, 1996.

I believe our mutual goal is the closure of this case, at which point a closure letter will be issued from this office, and signed by the Director of this Department. As you probably know, the closure letter is usually paramount in importance when doing a property transfer or refinancing a property loan.

The "Notice of Requirement to Reimburse," dated 12/26/95, addressed to John Lonacker should serve to answer your attorney's inquiry of our status as the lead agency.

I have attached a three page Fact Sheet which I just received today, which includes questions and answers regarding the **interim** guidance letter signed by Walt Pettit of the SWRCB. It refers to the ASTM standard for RBCA, and also states that "most fuel cleanup sites in the Bay Area are regulated by local agencies."
