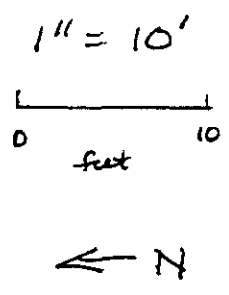
SAMPLE LOCATION MAP (TANKS A1 & A4)

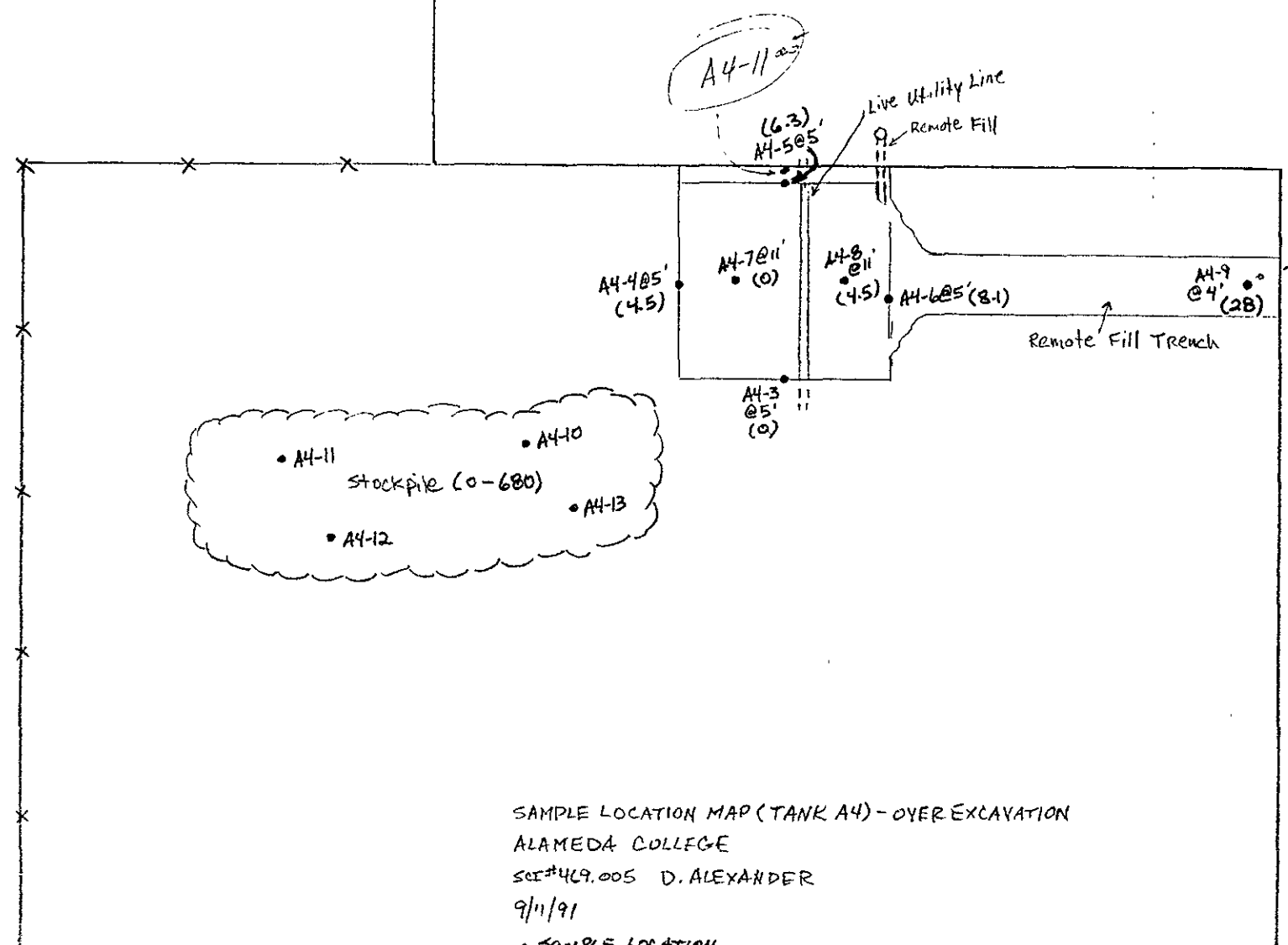
