This office has reviewed Quarterly Groundwater Monitoring Reports submitted by Hageman-Aguiar, Inc. dated July 18, and November 30, 1994 for the above site. The reports are acceptable with the following comments:

- 1. The first paragraph of the November 30 report is a little confusing. It says this is the second round of sampling since well installation. It appears this is actually the 4th round of sampling but that there were significant hits on Jan 7 and July 8. Sampling with contamination is not used to obtain closure of a site. Therefore the only sampling round that is helpful is a site being closed is the last one, dated October 6 mentioned in the last report.
- 2. It appears that several more rounds of sampling will be needed and some explanation for 1,200 ppb of TPHg on July 8, unless passive remediation has occurred. We look forward to you next report, which should have had sampling done in January 1995.

This office has received and reviewed a Report of Subsurface Investigation submitted by Hageman-Aguiar, Inc. dated January 11, 1994. The plan is accepted with the following comments:

- 1. The levels of contamination discovered in the soils are not significant. The TPHg contamination found in the monitoring well, although very low, requires monitoring for at least 4 consecutive quarters. 340 ppb is not a level considered to be "clean".
- 2. It is necessary that you confirm the gradient to assure that you are monitoring down gradient of the tank. Enclosed is a map showing other monitoring wells as small dots and other sites as larger dots. The consultant for Fidelity Packaging across the street also would like to use your well to confirm his gradient.



SECOND NOTICE

Dear Sir:

This office has reviewed reports of the underground storage tank removals performed at the above referenced site on January 3, 1991 and subsequent soil analysis. The last report was by Sampling Specialists Company dated October 28, 1991. The following comments are to be considered:

- 1. You were requested to begin a soil and groundwater investigation in a letter from this office dated March 14, 1991. No investigation has begun.
- 2. This office has no record of the disposal of contaminated soils which were removed from the tank pit by Pacific Excavators and reported in the above cited report. Please submit manifests of disposal for the contaminated and uncontaminated soils which were disposed off site.
- 3. It is clear that the elevated total petroleum hydrocarbon concentrations in soil at the above site require a soil and groundwater investigation.

I have enclosed the document, <u>Workplan for Initial Subsurface</u>
<u>Investigation</u>, a guidance document published by the Regional
Water Quality Control Board (RWQCB). Please be advised this
office is working in conjunction with the RWQCB to oversee the
remediation of hydrocarbon contaminated sites such as these. The
RWQCB is the agency entrusted to protect the waters of the state.

Please submit a workplan as described in the above document to this office within thirty (30) days of this letter.

You should consider this a formal request for technical reports pursuant to the California Water Code Section 13267 (b). All workplans, analytical results or reports should be sent to our

SECOND NOTICE OF VIOLATION

Dear owner/operator:

Our records indicate that there are underground tank(s) at your site at the above facility.

In accordance with the California Code of Regulations, Title 23, Chapter 3, Subchapter 16 Underground Tank Regulations you must perform one of the following actions:

- 1. Submit a tank closure plan to this Department as required by Article 7, 2670, or
- 2. Apply for a permit as required by Article 10, 2710. Permit applications are attached.

Please note that section 25299 of the California Health and Safety Code states that any operator or owner of an undergound storage tank is liable for a civil penalty of not less than five hundred dollars or more than five thousand dollars per day for failure to obtain a permit, or failing to properly close an undergound storage tank, as required by section 25298.
