STATUS REPORT ON COMPOSITE SOIL SAMPLING OF DRUMMED SOIL DRILL CUTTINGS FOR THE HILL LUMBER COMPANY SITE LOCATED AT:

1259 Brighton Avenue, Albany, CA 94706

Dear Susan:

Rafael and I dispersed 4 & ½ - 55 gallon drums of waste soil onto a sheet of 6 mil thick Visquene. Most of the soil filled drums found onsite were only partially filled and were therefore collected into 4 & ½ drums. This amounts to approximately 1 & ½ cubic yards of soil. We collected two composited soil samples and had them analyzed for TPHd, TPHg, and BTEX. The analyses identified 11 ppm diesel in the soil and no gasoline or BTEX in the soil. The analytical results are attached. We therefore request that we be given an approval to dispose of the soil onsite on the bare soil exposed at the southwest portion of the property.

Rafael and I will be collecting four (4) water samples, today, 3-18-96, from the 4 - 55 gallon drums which are onsite; as we did not collect them previously when we were collecting composite soil samples. We will analyze the water samples for TPHd, TPHg, and BTEX.

While we are onsite collecting water samples, we would like to also dispose of the soil if possible.
