Dear Keith,

Per our discussion regarding data requirements for uploading into your GeoTracker database, we are requesting an extension of time to the November 20, 2015 deadline to have these files developed and uploaded into this database. All files for the ftp website upload have been completed. Through this Notice to Comply for RO0001389, we did discover that our January 2013 SCM report had no record of being received, reviewed, or uploaded by Alameda County. Further, the County does not accept hard copies sent in to their office as their method of receipt, tracking, and reviewing. This SCM and Request for Closure Report has now been uploaded and you acknowledged receipt on November 12, 2015 and that Alameda County will review and provide notification within 60 days.

In order to extract data from our reports to collect the EDF file format for the laboratory analytical results, develop the excel files of groundwater and soil boring data in the format specified by the County, and extract the groundwater flow pattern diagrams for the GeoTracker database, we request an additional 31 days to complete this task for all of the data that we have collected through calendar year 2012.

Please grant this extension to December 21, 2015 and confirm this in an email.
