The 30-day extension of the public comment period for the subject site ended on November 15, 2014. No comments were received by Alameda County Environmental Health (ACEH). Thank you also for returning the *List of Landowners Form*.

Chevron is free to proceed with the destruction of all wells associated with the site (groundwater, vapor, etc), as requested in the attached August 6, 2014 letter from ACEH.

- **February 2, 2015** – Well Destruction Report (including Waste Disposal Documentation)
File to be named RO2435_WELL_DCM_R_yyyy-mm-dd

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.
