A "5-year review" is one of few statutorily mandated technical reviews to be conducted by the Cleanup Fund technical unit. Currently it only serves to provide a general summary of the case status and whether it meets the Low-Threat Closure Policy criteria. It does not play a role in any activity that is not related to the UST release corrective action, nor is it possible for the summary to cover all future land use scenarios.

This statutory requirement directs the Fund technical staff to prepare such "5-year review" for all claims 5 years and older, and do so annually, therefore the review has a very quick turnaround, and is not meant to drag on.

A staff level first draft summary was provided to ACDEH for internal comments on June 21, 2018. The draft summary suggested the case met all Policy criteria, and ACDEH may respond with any comments including disagreements. In any event, a case meeting Policy criteria does not preclude additional land use limitation or mitigation requirement imposed by local agencies due to site-specific conditions. Since such decisions are inherently local, they are not dictated by the State Fund staff.

## All,

The Alameda County Department of Environmental Health (ACDEH) has received a draft Review Summary Report (RSR) from the State Water Resources Control Board (SWB) for potential case closure. ACDEH is not in agreement with the draft RSR due to the vapor intrusion element which has been discussed extensively relative to site data, and ACDEH will need to discuss the site and data with the SWB to resolve our current differences of opinion. As you are aware, ACDEH, Responsible Parties, and redevelopment proponents have been consistently working and meeting together to move this site towards closure under a new land use scenario, that of residential multi-family units rather than as a service station or vacant land. Because ACDEH works under a contract to the SWB, until this difference of opinion is resolved, ACDEH will not be able to provide comments on the Vapor Mitigation System Basis of Design Report (VMS BOD) that is currently in our court for review comment. Due to Dilan's and my different vacation schedules this will delay any response until mid-September at best. This will obviously delay the current project schedule.
