Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

Responsible Party Identification

Existence of Unauthorized Release

Four USTs (one 10,000-gallon gasoline, 2-5,000-gallon gasoline USTs and one 550-gallon waste oil tank) were removed on May 23, 1986. Samples collected from soil reported a maximum concentration of 105 mg/kg motor fuels and 0.31 mg/kg benzene and groundwater was reported at 0.05 mg/kg motor fuel hydrocarbons. Separate phase hydrocarbons were also observed

Responsible Party Identification

Robert and Ellen Zweben, Shel Givens and Diane Wagner owned the property since June 1985 and removed the underground storage tanks in 1986. Therefore, Robert and Ellen Zweben, Shel Givens and Diane Wagner meet the definition of a responsible party for the site because they owned the property where an unauthorized release occurred, (Definition 3), they had control over an underground storage tank at the time or following an unauthorized release of a hazardous substance (Definition 4) and they owned a UST used for the storage of a hazardous substance (Definition 1).

The property was transferred to the Robert J and Ellen C Zweben Trust in December 1988. The Robert J and Ellen C Zweben Trust meets the definition of a responsible party for the site because they owned the property where an unauthorized release occurred, (Definition 3) and they had control over an underground storage tank at the time or following an unauthorized release of a hazardous substance (Definition 4).
