Dear Mr. Wiederhold and Mesdames Colbert and Andre:

Alameda County Department of Environmental Health (ACDEH) staff has reviewed the case file including the letter *Approval to Proceed with Installation of Sub-Slab Vapor Barrier and Venting System* provided by Jones Development Company, dated October 12, 2018. The letter documented a conference call on October 11, 2018 with ACDEH staff to discuss the installation of a vapor mitigation system (VMS) that was only preliminarily reviewed by ACDEH beneath the portion of the building at 2101 Williams Street that is subject to current tenant improvements.

As communicated, ACDEH has no objections to the installation of the VMS, provided that a vapor barrier is also installed on the surface of the concrete slab that is being replaced within that tenant space. As discussed in the conference call, ACDEH understands that an epoxy sealant product is required by the tenant to be installed on the concrete slab for moisture control. As communicated, ACDEH has requested the sealant product be capable of resisting the intrusion of chlorinated vapors.

Therefore, ACDEH requests that you address the following technical comments and send us the reports requested below.

TECHNICAL COMMENTS

- 1. Vapor Barrier Work Plan Request ACDEH requests a work plan for the installation of a vapor sealant on the concrete slab, and an installation schedule to facilitate ACDEH inspections. ACDEH will require Construction Quality Control and Quality Assurance documentation in a Record Report of Construction, inclusive of the following:
 - a. Thickness Measurements
 - b. Total Volume Determination
 - c. Batch Numbers
 - d. Photographic Documentation

Additional details will be provided at the time of the work plan approval.

REPORT & DELIVERABLE REQUESTS

Alameda County Department of Environmental Health (ACDEH) Cleanup Oversight Programs, Local Oversight Program (LOP) and Site Cleanup Program (SCP) require submission of all reports in electronic form to the State Water Board's (SWB) GeoTracker website in accordance with California Code of Regulations, Chapter 30, Division3, Title 23 and Division 3, Title 27.

Leaking Underground Fuel Tank (LUFT) Cases

Reports and deliverable requests are pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party (RP) in conjunction with an unauthorized release from a petroleum underground storage tank (UST) system.

Site Cleanup Program (SCP) Cases

For non-petroleum UST cases, reports and deliverables requests are pursuant to California Health and Safety Code Section 101480.

This letter must be signed by the Responsible Party, or legally authorized representative of the Responsible Party.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

AGENCY OVERSIGHT

Significant delays in conducting site assessment/cleanup or report submittals may result in referral of the case to the Regional Water Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.
