Dear Mr. Farrell:

I have completed review of Clayton Group Services' November 2000 Soil and Groundwater Sampling report prepared for the above referenced site. Clayton conducted a Phase I Environmental Site Assessment that identified potential areas where soil and/or groundwater may have been impacted by chemicals formerly used and stored at the property. Ten soil borings were advanced and a total of 12 soil and 9 grab groundwater samples were submitted for laboratory analysis. Samples were analyzed for TPHg, TPHd, TPHmo, BTEX, MTBE and/or metals (Cd, Cr, Pb, Ni and Zn).

Elevated TPHd and TPHmo were detected in soil samples from Boring B-2 at 7 feet bgs. And elevated TPHd and TPHmo were detected in grab groundwater samples from Boring B-5 and B-11. Residual contamination of concern appears to be limited mostly to the vicinity of the former waste oil UST and the hazardous materials storage area along the north side of the west shop.

It is my understanding the area with residual contamination will most probably be paved and used as a parking lot. Under this proposed use scenario, this agency will not require cleanup of the petroleum hydrocarbons. However, if hydrocarbon-impacted soil is encountered during excavation/trenching activities and is removed, it must be properly characterized and disposed. Documentation of soil and/or groundwater removal and confirmation sampling must be provided to this office. Be advised that further work could be required if conditions or site use change and more extensive/significant contamination is discovered at the site.

Dear Ms. Chu:

At your request, and on behalf of Shamrock Ford and Safeway, Inc., Clayton is pleased to present you with the attached maps for you review. Based on our telephone conversation of several weeks ago, I am forwarding you the attached ALTA Survey map of the Shamrock Ford property referenced above.

You requested this map to further evaluate the underground utility trenches and how they might effect the subsurface contaminants that Clayton identified in its Soil and Groundwater Sampling report dated December 7, 2000. The ALTA map indicates some of the subsurface utilities, and I have annotated some additional utility trenches. Please note that I have highlighted in yellow all known subsurface utilities, dashed lines where approximate and queried lines where I am unsure of their location. I believe that this represents the majority of the subsurface utilities; however, this does not represent a thorough survey of the property and other utilities most likely exist. I believe you will find that most of the subsurface utilities are outside of the areas where contaminants were identified with the exception of the shop floor drains that lead to sump/clarifiers and discharge to sanitary sewer lines.

This property is a remediated leaking underground tank site that received case closure by your office (LOP Case No.: 2127). On behalf of the concerned parties (Shamrock Ford – current property owner, and Safeway, Inc. – prospective purchaser), Clayton wishes to know what recommendations or requirements you might have after you have had a chance to review the attached map. Safeway proposes developing the property as a new supermarket and will pave the central and southern portions of the property as a parking lot.
