Dear Mr. Farrell:

I have completed review of Clayton Group Services' November 2000 *Soil and Groundwater Sampling* report prepared for the above referenced site. Clayton conducted a Phase I Environmental Site Assessment that identified potential areas where soil and/or groundwater may have been impacted by chemicals formerly used and stored at the property. Ten soil borings were advanced and a total of 12 soil and 9 grab groundwater samples were submitted for laboratory analysis. Samples were analyzed for TPHg, TPHd, TPHmo, BTEX, MTBE and/or metals (Cd, Cr, Pb, Ni and Zn).

Elevated TPHd and TPHmo were detected in soil samples from Boring B-2 at 7 feet bgs. And elevated TPHd and TPHmo were detected in grab groundwater samples from Boring B-5 and B-11. Residual contamination of concern appears to be limited mostly to the vicinity of the former waste oil UST and the hazardous materials storage area along the north side of the west shop.

It is my understanding the area with residual contamination will most probably be paved and used as a parking lot. Under this proposed use scenario, this agency will not require cleanup of the petroleum hydrocarbons. However, if hydrocarbon-impacted soil is encountered during excavation/trenching activities and is removed, it must be properly characterized and disposed. Documentation of soil and/or groundwater removal and confirmation sampling must be provided to this office. Be advised that further work could be required if conditions or site use change and more extensive/significant contamination is discovered at the site.

I have completed review of GeoStrategies' April 1994 Quarterly Groundwater Monitoring report for the above referenced site. this time, please continue with monthly measurement of ground water elevation and quarterly sampling of the wells. It is also acceptable to discontinue sampling groundwater for VOC's.

Should groundwater continue to flow toward the northeast, it may be necessary to install another well in the downgradient direction from the former underground storage tanks. And we will continue to watch the slightly elevated levels of chromium and nickel in groundwater. The next sampling episode should be in June 1994.

I have completed review of GeoStrategies' January 1994 Initial Subsurface Investigation report for the above referenced site. Water level data seem to show flow direction toward the The regional flow direction has been toward the northeast. southeast to southwest. A schedule to measure groundwater elevation on a monthly basis should be established to verify gradient and flow direction. Also, a quarterly sampling schedule should be implemented for the site. Technical summary reports documenting each well sampling and monitoring episode are also due quarterly. This schedule shall continue until further notice.

#### Dear Mr. Murray:

As requested in your letter dated March 28, 1991, the Alameda County Department of Environmental Health, Hazardous Materials Division, has reviewed its facility, underground storage tank (UST), and emergency response files for information relevant to your March 28 request. You may recall that the scope of the Department's search was modified from that originally requested March 28th, following our telephone conversations April 1 and May 17, 1991.

The new scope was to provide a listing of UST and hazardous waste generator sites at addresses on the listed streets within an approximate 1 mile radius from the subject site, and emergency responses occurring in proximity to the subject site; Proposition 65 and UST leak report files were not included in this data search.

The results of this search are presented below, in the order listed in the March 28 request. Only those streets for which information was found are listed:

As we discussed on the phone, the vast majority of streets listed in the March 28 correspondence are residential. The number of regulated businesses which may be located in these areas is limited as a result. Further, many areas in proximity to the subject site are still undeveloped; in fact, areas north, south and west of the site are still largely engaged in some form of agricultural activity (e.g., ranches and farms). Underground storage tanks found on ranches and farms are most often exempt from the underground storage tank laws in California. Hence, records pertaining to such tanks are, at best, limited.

This letter contains information limited to files located in this office, and does not reflect data that may be available from other agencies or parties, such as the Regional Water Quality Control Board or other county entities. The information presented herein is further limited by the reduced scope agreed upon during our telephone conversations April 1 and May 17, 1991.
