I would like to take this opportunity to introduce myself as the case worker for the subject Site Cleanup Program (SCP) case. I have reviewed Alameda County Department of Environmental Health's (ACDEH) case file and the State Water Resources Control Board's (SWRCBs) GeoTracker website for the above-referenced site.
