I am in receipt of the report "Risk Based Corrective Action Modeling", dated November 14, 1997, prepared by Jonas and Associates for the above referenced site. A risk assessment was conducted by using ASTM's Risk Based Corrective Action methodology (RBCA) to evaluate the potential risk to a future commercial worker due to the chlorinated solvents found in the groundwater and which is suspected to have an offsite source.

A 90% Upper Confidence Limit (UCL) of the average concentrations of chlorinated solvents found in the three monitoring wells during the last four round of sampling was used to evaluate the exposure to outdoor air and indoor air from the groundwater contamination.

Based on the information presented to this Department, the site does not pose a threat to public health and no further action is required.

As you know, this office is overseeing site remediation of soil contamination due to chlorinated hydrocarbons identified in the groundwater. I have completed review of the case file, including the recently submitted risk assessment report, dated November 14, 1997, prepared by Jonas & Associates Inc. It appears the site is ready for closure. However, the previous deposits totalling to \$950.00 (paid in 1992 abd 1993) have been depleted. Hence please send us a check made payable to "Alameda County, Treasurer" in the amount of \$1700.00 to take care of the current negative balance and future charges for the pending site closure work. Please make sure to write the address of the site in the check. This should be submitted to reinstate your account and complete this Department's oversight tasks on your project. Any and all monies remaining in your account after the completion of the project will be refunded to you.

For your records, I have attached all the charges made on your site beginning from the year 1992. Dear Mr. Jonas:

I am in receipt of the Groundwater Monitoring Report, dated November 10, 1995, prepared by Jonas and Associates, Inc. documenting the results of the third and fourth round of groundwater sampling conducted at the referenced site. Also, I have received a letter from you, dated February 28, 1995, requesting a reduction in the frequency of groundwater sampling from a quarterly to an annual basis.

Since the current groundwater sample results indicate the presence of chlorinated solvents in monitoring well, MW-2 which points to an upgradient source, this Department is in the process of investigating Style Center Cleaners located adjacent and upgradient to your property at 1353 E.14th Street in Oakland, California. However, since chlorinated solvents have been identified in the soil samples collected from the referenced property, this Department would require that groundwater monitoring be continued on an annual frequency on all the three monitoring wells on site.

In order for this Department to understand the previous site use/history of the referenced site, please provide a copy of the phase I investigation done by Environmental Mitigation Group (EMG) in the year 1990 and which was referenced in the document dated October 26, 1996 prepared by Jonas and Associates, Inc. If this is not available, then a detailed phase I assessment should be conducted in order to provide a complete site history of the property to this Department.

The referenced site will be re-evaluated for closure if additional data/information is available that could eliminate it as one of the sources of solvent contamination in groundwater or if this Department has reasons to believe, based on information submitted that the site does not pose a threat to public health or to the environment.

Dear Ms. Heffner:

Alameda County Environmental Health Department, Hazardous Materials Division has received and reviewed the work plan dated June 4, 1993, prepared by Jonas and Associates, regarding further investigative work at the above location.

Earlier work performed by a consultant for a prospective buyer of the property disclosed the presence of contamination to groundwater from diesel at 190 ug/L, 1,1-DCA at 15 ug/L, 1,2-DCE at 19 ug/L, 1,1,1-trichloroethane at 3 ug/L and trichloroethylene at 12 ug/L. Samples collected of oil inside a hydraulic reservoir indicated 6.4 ppm of PCB (Aroclor 1232). You are requested to provide a copy of this report to this Department for review. It is my understanding that during the installation of monitoring well # 1 (MW-1) no soil samples were collected.

The work plan proposes the installation of two monitoring wells and the collection of soil samples at 2.5 foot intervals.

The work plan is unacceptable for the following reasons:

- 1) The plan states that samples will be screened with an organic vapor analyzer (OVA) and if organic vapors are detected they will be submitted to the laboratory for analysis. Because the use of a OVA is only a field screening instrument you are required to collect and analyze samples at every 5 feet or change in lithology.
- 2) It is my understanding that soil data were not analyzed in the area of MW-1 at the time of the well installation. Because this data point is presumably closest to the hoist areas near the area of MW-1 you are required to collect soil samples every 5 feet of change in soil lithology. Based on field observations, at least one of the soil samples collected must be analyzed for the presence of PCBs. This request is made because the presence of PCB was detected in the hydraulic reservoir.

- 3) In addition to the TPHd and purgeable halocarbons you are also required to analyze all soil and groundwater samples for the presence of benzene, toluene, ethylbenzene and xylene.
- 4) Have your Consultant discuss the labelling and storage of all drums containing drill cuttings and purge water.
- 5) Have your Consultant notify this Division with as much advance notice as is feasible prior to initiation of the work at the site.

Alameda County Environmental Health Department, Hazardous Materials Division has received and reviewed the report which evaluated the nature of the spilled material which occupies an approximately 300 square foot area on the outside surface of the abandoned General Tire facility at the above noted address. The report prepared by Jonas & Associates, dated November 24, 1992, outlines results of sampling for the presence of the California Code of Regulations, Title 22 CAM 17 metals. Additionally, an analysis for the presence of volatile organic compounds was performed. Both analysis indicated that no significant hazardous waste constituents were present. The report also documented the high adhesion and low solubility of this material onto both asphalt and concrete.

Based upon all information available to this office at this time no additional requirements are necessary regarding the above matter.
