Dear Ms. Logan:

On behalf of Continental General Tire, Inc., presented below is a brief work plan for additional site investigation and remediation at Continental General Tire's facility located at 1201 14th Avenue, in Oakland, California.

Scope of Work

As per your recommendation during the November 5, 1998 site visit, Continental General Tire, Inc. shall perform the following additional activities at the site:

1. Additional lateral soil excavation at Pits E and C2.

After excavation, collect one soil sample from each pit and analyze for the following parameters:

- Total Extractable Petroleum Hydrocarbons as diesel, kerosene, and motor oil (TEPH-d,k,mo): EPA Method 8015M.
- Miscellaneous Metals: EPA Methods 3010A/3050A/6010A Nov. 1990 (LUFT Metals).
- Volatile Organics by GC/MS: SW846 Method 8260A Sept. 1994.
- 2. Pump water from Pit E and Basins B1 and B2.

The water will be periodically pumped and stored in a Baker Tank. After 30-days, groundwater samples will be collected from Pit E and Basins B1 and B2. The samples will be analyzed for the aforementioned parameters. Water collected in the Baker Tank shall be properly disposed of.

Install a groundwater monitoring well downgradient from the basin locations. Sample the well and analyze for the aforementioned parameters.

- 4. Backfill the excavations and resurface after approval by the Agency.
- 5. Perform quarterly monitoring of the four groundwater monitoring wells for a period of one year. Submit quarterly groundwater monitoring reports.
- 6. Perform an environmental risk assessment and request for a site closure.

As you know, the property is being sold and Continental General Tire would like to close the site as soon as possible. Therefore, we would like to begin work by Wednesday, November 11, 1998 and would appreciate your prompt response.
