Vicki.

I have reviewed the RO2483 case file for 4240 International in Oakland and discussed the case with Donna Drogos. Case RO2483 can be considered for case closure with a deed restriction to limit future use of the site to commercial land use. Based on residual contamination remaining on site, the site cannot be closed for unrestricted future use. I have attached a copy of the model Alameda County deed restriction that would be used as a template for a deed restriction. The site-specific language in the deed restriction can be modified but the standard legal language must remain intact. Here is how I see the process going forward:

- 1) In order to begin the case closure process, I will need to prepare a closure summary for approval by my management. Unfortunately, the case has a negative funds balance. Therefore, I will be sending out a request for a deposit tomorrow.
- 2) Once the funding is in place and I complete the closure summary, it goes to my management and then the Regional Water Board for review and approval.
- 3) You will need to submit the completed deed restriction for our approval.
- 4) After approval of the case closure summary and deed restriction, the deed restriction is signed by the property owner and Director of Environmental Health with notarization of the signatures.
- 5) After we have confirmation that the deed restriction was filed with the County Recorder, a case closure letter can be issued.

There are two other items that came up in review:

- 1) There are references in several reports to fuel conveyance piping and vent pipes for the former fuel tanks remaining in place along with recommendations to remove the piping. Do you know the final resolution regarding the piping for the former fuel tanks?
- 2) A second UST case shows as an open case for 4240 International on the State Water Resource Control Board Geotracker website. This second open case may refer to the Super Tire Facility. I will try to resolve this issue and correct the Geotracker database.
