I provided a list of needed items to move this case towards closure in my email dated April 14, 2010 (see attached). The first two items required from you on that list were the funding for regulatory oversight and a draft deed restriction (I sent a model deed restriction to use as a template). A request for funds was also issued in my April 15, 2010 letter (also attached). To my knowledge, we have not received the funding or the draft deed restriction.
