Paresh,

In the meeting we had with Mary Rose Cassa, Steve Plunkett, and Donna Drogos, we discussed the issue of a soil boring at 2863 Helen and the consensus was it was not needed. I brought a revised figure to the meeting that showed the property at 2863 Helen was primarily north of the excavation at 1549 32nd Street. Later, Steve asked for the same boring again and I responded to him at that time (see the attached email). I believe Mary Rose remembered that that boring could be omitted because when it was originally requested, no one realized how that property was oriented relative to 1549 32nd Street.

We have discussed the issue of angled soil borings with our Geoprobe driller at great lengths and we will not be able to achieve any significant horizontal distance even with the Geoprobe truck, let alone the limited access equipment necessary to drill the soil borings in the rear of 2859 Helen Street.

This continued debate is pointless. We can at the very most encroach 6-8 feet into the property at 2851 Helen Street using the truck, and we risk breaking rods and core barrels trying to do that. At least if we angle into 2851 Helen from the west from 1549 32nd Street, we'll get some useful data. Or we can collect grab groundwater samples at the extent of our property.

Can we please resolve this?
