As discussed on Tuesday, 5 November 2013, the subsurface investigation scheduled to begin at the referenced site on 4 November 2013 has been delayed because of a property access issue. It recently came to our attention that the site is being used for parking for a nearby construction project (7 AM to 3:30 PM Monday – Friday) and it is expected that this parking arrangement will continue into 2014. The scheduled work cannot be conducted at this time. Therefore, on behalf of ExxonMobil Environmental Services, we request an extension of the Soil and Water Investigation and Focused SCM Report due date to 10 March 2014.

We will be requesting a timeline for construction from the property owner and will keep you informed if additional delays are anticipated.

It is my understanding that you will respond to this email correspondence and upload to the County FTP site, and to GeoTracker. You will also provide contact information for the worker assigned to this case replacing Barbara Jakub.
