Paresh,

This email serves to request an extension on investigation work activities proposed in the September 2, 2008 Work Plan for Ground-Water Investigation at the subject site. The ACEH approved work activities in their September 17, 2008 letter and requested that the following schedule be met:

October 15, 2008 - Complete fieldwork
November 12, 2008 – Soil and Water Investigation Report and Quarterly Monitoring Report (3rd Qtr. 2008)
January 30, 2009 – Quarterly Monitoring Report (4th Quarter, 2008), etc...

Two of the three proposed clustered well locations are within the sidewalk to the north and across Park Boulevard. The City of Oakland originally stated that they no longer allow monitor wells installed within sidewalks. However, after discussion of site specific conditions that limit moving wells to the south (utilities) and the north (steep slope) they stated that a formal application would be considered. Stratus is in the process of submitting a formal application. Accordingly, it

is not feasible to meet the above deadlines. As it is not currently known when access will be granted it is requested that deadline(s) not be specified at this time. We will continue to provide updates to ACEH regarding progress with investigation activities.

Please let us know if you approve this request. Also, I am temporarily filling in for Tom Venus as project manager for this project. Tom will return to project manager duties in the near future.
