NOTIFICATION OF POTENTIAL CASE CLOSURE OF SITE CLEANUP PROGRAM CASE Tract 7305

Summary – This fact sheet has been prepared to inform community members and other interested parties of potential case closure for a Site Cleanup Program (SCP) case at 4605-4653 Malabar Avenue, Castro Valley, California. The property was originally a four-acre parcel which was subdivided into 17 residential lots in the mid 2000's. Site investigation activities have been completed and it does not appear that remaining residual site contamination presents a risk to human health based upon current and projected future land use.

Background The original four-acre parcel was used as a chicken farm from the early 1900s through the 1960s, and then for row crops between 1975 and 1988. A gasoline underground storage tank (UST) and pump were located adjacent to a vacant house (4611 Malabar Avenue) and were reportedly removed in the 1960's.

Environmental investigations were conducted in 2000 and 2003 to determine the extent of soil contamination in preparation for future property development.

Three soil borings were drilled in the immediate vicinity of the former gasoline UST and 20 shallow soil samples were collected across the site in areas that may have been used for row crops. Groundwater was not encountered to nine feet below ground surface, the maximum depth explored. Soil samples collected from the vicinity of the gasoline UST did not contain detectable total petroleum hydrocarbons as gasoline (TPHG), benzene, toluene, ethylbenzene, xylenes (BTEX) compounds, methyl tert-butyl ether (MTBE), or other volatile organic compounds (VOCs) compounds. TPH as diesel (TPHD) was detected just above the laboratory detection level in one soil sample. Shallow soil samples collected in possible row crop areas did not contain detectable pesticide concentrations. Site investigation activities have been completed. Therefore, ACEH is considering potential closure of this SCP case.




Figure 1: Aerial View of Property (Google Earth, 2013)
