Hi Andy,

I completed review of the case file and discussed some the comments of concern with my supervisor, Donna Drogos, as well as with the Regional Water Quality Control Board staff, Betty Graham. Below are my comments:

- Dave Sadoff says that both the north and south portion of the site had row crops or an orchard. Soil samples were
 only collected from the south portion of the site. Soil samples should be collected from both the north and south of the
 site (in the area of the former row crops or orchard) and analyzed for organophosphorous pesticides and chlorinated
 pesticides. Soil samples should be collected at a rate of one soil sample per 5000 sq feet. Samples should be
 collected from the surface (0.5 to 1 feet below grade surface, bgs) and from 2.5 to 3.0 feet bgs.
- It should be determined if chemicals/pesticides were stored and mixed at the site. If so, additional soil samples should be collected in the vicinity of the storage/mixing areas.
- Another attempt should be made to collect a soil samples (at approximately 6 to 8 feet bgs) from the former
 underground storage tank area. A boring should be advanced to first groundwater and a grab groundwater sample
 should be collected. This boring may be located within 10 to 20 feet of the former UST in the southwest direction
 (anticipated groundwater flow direction).
- Please provide information on the construction detail of the former water supply well and the method by which the
 former well was abandoned. If it was not pressure grouted from the bottom up, it may need to be properly
 decommissioned.

A workplan should be provided to address the above concerns. If you have any questions, please call or email.
