Hi Barb,

I'm doing a Phase I on 5855 Horton Street, currently the Terraces Apartments and Garage (Emery Station III), formerly 1520 Powell Street, Chevron Asphalt. I see from the latest Arcadis Workplan that Steven Plunkett was the regulator handling the site. Do you know who is currently handling this site? I was hoping they could answer a few questions for me. Would you mind forwarding this on to whoever is overseeing the site?

- 1) I've reviewed the site history and all of the documentation on the Alameda County, Water Board, and Envirostor websites (plus some provided by the current owner Warham Development), but I don't see anything from any of the regulatory agencies naming Chevron as the responsible party or issuing any orders. Was Chevron ordered to do the investigation/remediation or is this voluntary?
- 2) I've read the Arcadis Workplan dated 2008 describing the installation of additional wells. It appeared as if those wells were installed during my site visit yesterday but I haven't seen any report documenting the installation or seen any groundwater monitoring reports (the latest available is from 2008, prior to the submittal of the workplan) with info from the new wells. Was this workplan submitted by Chevron per a directive by a regulatory agency or voluntary done? Have the wells been installed and monitored? Is it possible to get information on the results? I'm specifically looking for current concentrations on the wells located on the property (from the Workplan MWX11A, MWX10A, and MW-12).

Any information you can provide will be appreciated. Thanks!
