Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

Responsible Party Identification

Existence of Unauthorized Release

On January 7, 2004, one 2,000-gallon gasoline underground storage tank (UST), dispenser, and related product piping was removed from the subject property. Maximum concentrations of petroleum hydrocarbons detected in UST excavation and dispenser samples were 6,400 milligrams per kilogram (mg/kg) total hydrocarbons as gasoline (TPH-g), 6.4 mg/kg benzene, and 19 mg/kg ethylbenzene. Tank pit water sample maximum concentrations of petroleum hydrocarbons were 8,600 micrograms per liter (?g/L) TPH-g, 570 ?g/L benzene, and 150 ?g/L ethylbenzene. These data indicate that an unauthorized release had occurred.

Responsible Party Identification

Allied Land Company purchased or acquired Assessor's Parcel Numbers (APN) 70-195-3, 70-195-4, 70-195-5, 70-195-15, and 70-196-23 on September 5, 1962, and APN 70-195-7 on January 29, 1965. Allied Land Company is a responsible party because in the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use is a responsible party (Definition 2) and they are the owner of the property where an unauthorized release of a hazardous substance from an underground storage tank has occurred (Definition 3).
