Mr. Nowell,

On behalf of Rolls-Royce Engine Services – Oakland (RRESO), PES Environmental, Inc. (PES) is responding to your April 1, 2013 request regarding submittal of the Tier II Risk Assessment by August 7, 2013. PES, on behalf of RRESO, respectfully requests an extension on the due date for submittal of the Tier II Risk Assessment. We are requesting that the Tier II Risk Assessment be required for submittal to Alameda County Environmental Health (ACEH) 90 days following receipt of ACEH comments on the Tier I Screening Assessment.

The rationale for the extension request follows. As you know, the Tier II Risk Assessment will need to respond to ACEH comments regarding the Tier I Screening Assessment dated October 22, 2010. RRESO has not yet received ACEH comments on the Tier I Screening Assessment. Additionally, the Tier II Risk Assessment that RRESO will prepare is reviewed by the Port of Oakland and its consultant prior to submittal to ACEH. Accordingly, the extension is required in order to fully respond to ACEH comments and prepare the Tier II Risk Assessment in a collaborative manner with the Port of Oakland.

Dear Mr. Dave Goldberg,

Alameda County Environmental Health (ACEH) has prepared this letter to follow up with our meeting held on February 27, 2013 to discuss the subject site. In an email correspondence on March 8, 2013, ACEH transmitted meeting notes documenting items identified at the meeting requiring additional communication between Rolls Royce and ACEH; however no dates were discussed for task completion (see attached file).

In order to facilitate moving the case forward, ACEH requests you address the items identified in the meeting notes, perform the following work, and upload the requisite documents to the ACEH ftp site and the State Water Resources Control Board's GeoTracker website in accordance with the schedule provided below:

1. A case file review to identify reports missing from the ACEH ftp site and GeoTracker website, to be completed **by May 1, 2013**;
2. Submittal of a Revised Proposed Monitoring and Sampling Plan, to be completed **by May 1, 2013**;

Once we have received notification of the file uploads of the documents identified in Items 1 and 2 above, ACEH will review the case file with respect to the gray water discharge to the wetland east of the site and communicate our findings to you regarding our recommendations for chemicals of concern to be used in the Tier II Risk Assessment. ACEH will complete this review within 60 days of the date of notification of the file uploads.

3. Tier II Risk Assessment, to be completed **by August 7, 2013**

ACEH looks forward to working with you to move your site towards case closure. Thank you for your cooperation.
