On behalf of Rolls-Royce Engine Services – Oakland (RRESO), PES Environmental, Inc. (PES) respectfully requests a 60 day extension for submittal of the Revised Proposed Monitoring and Sampling Plan, requested below. The due date for the Revised Proposed Monitoring and Sampling Plan is currently May 1, 2013. The requested 60 day extension would result in a revised due date of July 1, 2013.

RRESO's contractor recently completed a semi-annual groundwater monitoring event at the Test Cell facility and the groundwater monitoring results are not available at this time. This request for the 60 day extension is being made so that the results of the March 2013 sampling event can be evaluated and considered in proposing revisions to the monitoring and sampling plan. The next sampling event is not scheduled until September 2013 and the revised due date should allow sufficient time for ACEH review and response prior to the next planned sampling event.

Alameda County Environmental Health (ACEH) has prepared this letter to follow up with our meeting held on February 27, 2013 to discuss the subject site. In an email correspondence on March 8, 2013, ACEH transmitted meeting notes documenting items identified at the meeting requiring additional communication between Rolls Royce and ACEH; however no dates were discussed for task completion (see attached file).

In order to facilitate moving the case forward, ACEH requests you address the items identified in the meeting notes, perform the following work, and upload the requisite documents to the ACEH ftp site and the State Water Resources Control Board's GeoTracker website in accordance with the schedule provided below:

- A case file review to identify reports missing from the ACEH ftp site and GeoTracker website, to be completed by May 1, 2013;
- 2. Submittal of a Revised Proposed Monitoring and Sampling Plan, to be completed by May 1, 2013;

Once we have received notification of the file uploads of the documents identified in Items 1 and 2 above, ACEH will review the case file with respect to the gray water discharge to the wetland east of the site and communicate our findings to you regarding our recommendations for chemicals of concern to be used in the Tier II Risk Assessment. ACEH will complete this review within 60 days of the date of notification of the file uploads.

Tier II Risk Assessment, to be completed by August 7, 2013
