Sara,

I used an online lat and long converter (from decimal to minutes and seconds) so I could use it with Google Earth. The online converter indicates that the lat and long you provided is down on Glenview Avenue across the freeway from 536 Cleveland Ave. So that said, I'm not even sure the online converter is correct. Regardless, I do not have much knowledge about the case at 536 Cleveland as the RP has been inactive recently.

I would recommend that you review all of our case files (PDFs) through our website (see link below my name). Everything we have is there. Since the work was done before Geotracker was started and uploads were required, there will be no files on Geotracker (yet). A quick review of the reports indicate that the site is a both a soil metals case and a petroleum UST case. A worker health and safety plan can be generated to deal with the known / expected contaminants.

Western Forge and Flange (540 Cleveland) is likely getting close to closure, after a number of remedial excavations were conducted early last year. It is / was also a soil metals case, although there is a groundwater component as well. I mention it as the metals contaminants appear to be somewhat similar and may be related to a similar generation process (but that's a guess or suspicion only) as we aren't aware of the fill history of the area. Hope this helps. If you have additional questions, let me know.

Good Afternoon Mr. Detterman, Ms. McCaulou, and Mr. Jemison:

PG&E is providing a courtesy notification to DTSC, Alameda County, and San Francisco RWQCB (Region 2), informing you of PG&E's project to replace a single power distribution pole. The pole will be replaced using hydraulic tools and hand tools (such as shovels, picks and pole anvils). Ground disturbance will be limited to approximately 4 square feet.
