Dear Mr. Nagra:

On February 20, 1997 I performed a Hazardous Materials Business Plan inspection at your above facility. During this inspection, I observed an oil spill on the soil near the office trailer that will have to be cleaned up. I collected a sample of this stained soil. I have enclosed a copy of the laboratory analytical results from this sample.

Our lab results indicate Total Oil and Grease (TOG) content of 9.6% or 96,000 parts per million. There is a concern that levels of TOG, metals or other contaminants will exceed hazardous waste regulatory criteria specified in Section 66261.20 of Title 22 of the California Code of Regulations. You are therefore required to either perform laboratory analysis as per the above criteria or to perform a soil cleanup.

Submit a work plan to this office within 30 days to address this soil contamination. The work plan should include: a description of soil remediation measures of the affected area; confirmatory soil sample analytical results of the same area; analytical results from the excavated soil and soil disposal receipts from an approved disposal site.

You are required to have soil confirmation samples taken beneath the affected area to indicate that all contamination has been removed. The sampling must be conducted by an authorized third party laboratory that is certified to perform total petroleum hydrocarbon analysis or other criteria required by an approved disposal site. 

Dear Mr. Eash:

I have reviewed the above referenced proposal and find it acceptable as a preliminary outline of work planned for your site. In addition to the steps and procedures outlined in the proposal, you must include in your formal workplan:

- Exact proposed locations of the three monitoring wells.
- 2. Plans for sampling purged groundwater and drill cuttings in order to determine proper disposal method for these materials.
- 3. An expansion of groundwater sampling to include total petroleum hydrocarbons as diesel as well as TPH as gasoline and benzene, toluene, ethyl benzene, and xylene.
- 4. Agency document distribution list, which, at a minimum, should include this office and the Regional Water Quality Control Board (RWQCB). Copies of all workplans for investigation and remediation activities, as well as sampling and progress reports, must be submitted to the above listed agencies.

To cover this agency's oversight costs for the project, you must submit a check for \$500 to this office, payable to County of Alameda. Your formal workplan must be submitted to this office no later than January 15, 1991. You may contact me with any questions at 271-4320.

Dear Mr. Eash:

I have reviewed the sampling results for the work carried out by Tank Protect Engineering on August 28, 1990. I have the following concerns about your site:

- 1. Above detectable levels were found in Soil Borehole 2 of various petroleum fuel constituents at depths below 10 feet.
- 2. No groundwater sample results were presented, yet groundwater is known to occur within six feet of the ground surface at an adjacent site. As I specified in my letter of August 20, 1990, you were required to submit both groundwater and soil analysis results.

You are required to submit boring logs for the sampling that was performed on August 24. You are also required to submit any groundwater analysis results you may have for the site. This data must be submitted to this office no later than October 31, 1990. You may contact me with any questions at 271-4320.

In accordance with the California Administrative Code, Title 23, Chapter 3, Subchapter 16 Underground Tank Regulations you must perform one of the following actions:

- 1. Submit a tank closure plan to this Department as required by Article 7, 2670 or

On June 7, 1989 you requested and were sent 3 copies of our Closure Plan instructions. To date we have not received any other response.
