Discussed 42' depth of GW samples, they selected an arbitrary depth, did not log geology at site did not review data from adjacent site, have only 1 gw sample collected do not know extent of plume how can they make the conclusion that site poses no risk? Not enough data to make that conclusion.

He agreed, they made a conclusion on the limited data they had. I said they did not have enough data to make any conclusion about risk at site.
