

This Department is currently updating all site investigations under the jurisdiction and oversight of the Department. The Golden Grain site at 1111 139th Avenue, San Leandro, CA 94578 is currently an open file. The records for this site describe an investigation started due to the removal of three underground storage tanks. Diesel contaminated soils were to be treated onsite using a bioremediation technology. No further information exists in the file to document activity at the site after the treatment proposal.

In order to update the file and to evaluate the current site conditions you are required to submit all documents related to the subsurface investigation and tank closure. Please include all laboratory analytical data on soil and groundwater samples, monitoring well boring logs, depth to groundwater and gradient calculations.
