>>>I wanted to contact you to both introduce myself and to provide you with my contact information, as well as to let you know that I have an inquiry out as to the status of the disposal or securing of the 55-gallon drum of soil. Based on the date of the drum, it was generated during a recent environmental subsurface investigation on December 7th at the site (the date on the drum). Based on the analytical included in the report for that investigation which we have received, only very minor (trace) concentrations of petroleum hydrocarbons were detected in the soil. It will not be a health hazard, but is more of a potential trip hazard at this point. I hope to have more information shortly and will keep you posted. I do not know if I will hear back today, but if not I will put it on my calendar for followup on Tuesday. We will be observing the holiday on Monday.
