Site issues:

Site maps from reports conflict, not to scale - Robert will have accurate surveyed map in SWI report.

UST orientation, Dispenser location & content of each UST uncertain. Records missing info. He has no photos from UST removal.

FP in SB2 water sample

Highly contaminated under USTs, 10k ppm TPHD at 8'. Did not detect this contamination in surrounding soil borings. Sample at appropriate 7 enough depths?

He will include data from UST removal in tables in future reports.

Had proposed excavation & ORC, but not in USTCF so going a cheaper longer term alternative, possibly peroxide injections.

He will add DTW to site tables.

He noted discrepency on DTW for SB8 on x-section. He will review & revise x-section accordingly.

No buildings on the site. Demolished.

Some confusion over property boundaries, 2 sites & 2 sets of owners. However, all owners indicate they own all properties.

Want to develop into condos. Bldg footprint located over UST location. 1986 geotech borings (for proposed apartment) appeared to have drilled through UST vicinty??, but contamination not noted?

He will add footprint of proposed condos onto site plan in SWI.

Discussed appropriate tables for ESLs. Use potential drinking water source, site is not de-designated as a drinking water source in basin plan. He will revise in his future tables.

We discussed issue of meeting on 10/15 will aggerty, too preliminary, he feels that a demittive direction for the site will not be available then. Will have to consider addtl future MW data & will be working on determining next steps at site: addtl work? Or right to remediation? Or both? Too early to tell. He will assist Piazzas with report interpretation and determining a reasonable schedule to proceed. We agree that Haggerty's thoughts re: closure by Dec. 2007 premature. Robert suggests a 1 year time frame (estimate) may be more realistic, provided current source remaining is not large.



Dh: The workplan needs to be revised to reflect what's proposed.

Flory: In 30 days, will revise workplan to propose soil excavation at source, then ORC placed in the excavation before backfilling, followed with groundwater monitoring.
