Please find attached two memoranda highlighting our activities in the Sunnyside Nursery development project.

We are currently working with the City of Hayward, the owner of the property Mr. Yoshida and representatives of the developer "Plymouth Group" to expedite the process necessary for mitigating this site. The complexity of this process is manifested in the following:

- City of Hayward is considering annexing the site after filing negative declaration including but not limited to the absence of soil contamination. This condition cannot be attained unless the site is properly cleaned to meet the negative declaration requirements.
- 2) The developer "Plymouth Group" is requesting an immediate approval on a plan of correction for the cleanup of the site.
- 3) It is the understanding of this Department that the property owner will continue operating the nursery activities after the plan of correction is submitted, reviewed and accepted. This activity will in effect render the plan of correction invalid because of potential use of pesticides and consequently the change of soil contamination data. We are working very closely with all agencies to evaluate the site and reach a decision within the requirements of the statutes and regulations. It is in the best interest of all concerned that this site receives adequate oversight in order to avoid any future liabilities.

The staff of this Division are overseeing over 400 sites with various degrees of complexity. Staff services to the Nursery site are being expedited within the limitation of staff and regulatory requirements.

Sunnyside Nursery events to date:

Received a call from Tak that Supervisor Santana has requested information concerning the events taking place with the above site being evaluated for residential development.

The following are as I recall the events:

June 1 or 2 I received a call from Supervisor Santana and I informed him that a meeting was being called by the City of Hayward Fire Dept. Steve Falez and Planning Dept. Diane Anderly for the following week and I would be at the meeting. He requested I see what could be done to expedite the activity. I told Him to have Mr. Yoshida call me next week and I would inform him of activities.

June 8,1989 Met with Steve Falez and Diane Anderly of the City of Hayward with Tom Peacock. We reviewed what was before us the plan for development on the site presently occupied by Sunnyside Nursery. The City is evaluating if a negative declaration is possible rather than a full fledged EIR. According to Diane in order to get the neg. declaration she must be able to answer no to a number of questions. including is there any contamination of the soil. A preleiminary report has been given to the developer Plymouth Group. Tom has reviewed it and we now need the sampling plan for the area, after the plan is approved and sampling completed then we will evaluate if the mitigation plan provided by the consultants is acceptable.

Call from Mike Green Ag. Commissioner Alameda Co. He stated that Mr. Yoshida had called him and that the tanks on the site are agricultural and exempt from permitting and testing. I informed Mike Green that the tanks are not less than 1000 gallons and used for agricultural equipment (off road) only and therefore are not exempt from our inspection, permit and fees. I told Mr. Green to have Mr. Yoshida call me and I would explain to him the above.

Mr. Yoshida called and I informed him of the above and that the permit and inspection fees would not be in the multiple of 10s of thousands of dollars. also if he so desired he could remove the tanks now to facilitate the transfer of property and do the testing of the area under the tanks to show that no contamination exists. He then could install above ground tanks for fuel for the remaining 10 months he plans on operating. He said he would come in next week and take out the necessary permit application and 2185 business plans.

Received a call from a Mr. Scott Wray of Plymouth Group, He stated that he wanted to meet with me concerning the site and I informed him that a letter had been written to Him and when he received the letter if a meeting is necessary then he could call for one.

Mr. Wray called later in the day and said he wanted a meeting I told him that I could not meet the next week due to prior commitments but the week after was available. He stated this was unacceptable and he wanted a meeting the next week, I told him to call mon and speak to either Mr. Shahid Chief, or Tom Peacock Sr. Spec. working on the site.

Tom met with the Plymouth group on tues. 6/13/89 and I have requested his notes for this site.
