Cherie at the RWQCB is our contact person for public notices; however, the RWQCB has not commented on our closures in several years. She is notified and has the opportunity to comment on potential closures just like everyone, but the RWQCB has considered it redundant for some time. It is probably a city of Hayward artifact, as they were (?) an LIA, which was not required to maintain a professional (PE / PG) on staff (until very recently). ACEH is an LOP, which is required to do so. In fact all staff at ACEH are either PE / PG (CEG / CHG) licensed.

The City of Hayward Planning Division is asking for a "clearance certificate" from the RWQCB (or DTSC) "that the property meets investigation and cleanup standards for residential development". It is a Planning Dept. condition prior to issuing the grading or building permit. That came from Hugh at the City (haz mat representative at the Fire Dept.). I called Hugh yesterday afternoon and talked it over. He is thankful of the work performed. I emailed Hugh the GeoTracker link. He wants something in writing from the RWQCB. Cherie is listed on GeoTracker as the RWQCB contact, but that may just be an artifact from a while ago.
