Thanks. Good data and quick to digest.

I've several probably minor requests to hopefully move the case towards closure. To keep it simple these items could be provided as a site investigation addendum, so the report can stand unaltered. Alternatively it can be modified with the data, as they are a standard submittal to all reports. The details:

- The report states that the drilling permits and well completion reports are attached to Attachment 1 of the report. Only the permits were attached, and they likely will help support the closure.
- I did not locate analytical for bore P5, and will need it to document the site fits the Low Threat Closure Policy. I did a search and tabbed through pretty much all the lab sheets. Perhaps it was labeled as something else?

I can send a formal letter requesting these items if needed, but this seemed to be the simplest and fastest at this point.
