Mr. Kershaw,

Thank you very much for the email. The Notice to Comply is actually a request for you to claim the site in the state web-based database rather than the county web-based database. I did check the county web database and there are a number of PDF documents there as you indicate. Because it's pretty much the same effort to upload PDF reports and other info to the Geotracker (once you claim it) as it was to the county database, it would be great to get the information uploaded to Geotracker. As you note you site does not currently have monitoring wells, which will make the data uploads to Geotracker somewhat simpler.

You can you claim the site in Geotracker at the link provided on the Notice to Comply letter, or you can go to another link -http://www.swrcb.ca.gov/ust/electronic_submittal/index.shtml and open the "Beginner's Guide" under "Getting Started", or just call the toll free number in the upper right corner and the Help Desk can walk you through the process. Since I've not claimed a site, I don't really know how it's done; so the Help Desk may be your best bet. I hear it's pretty easy however.

Once the site is claimed, please send verification that it has been claimed (screen shot, or the confirmation email from Geotracker help which I've seen several times already).
