Dear Mr. Grayson:

I have been assigned as the case worker for this fuel leak case. Please send future correspondence to my attention. Alameda County Environmental Health (ACEH) staff has reviewed the fuel leak case file for the above-referenced site including the most recently submitted document entitled, "*Data Gap Investigation Work Plan*," dated December 6, 2013 (Work Plan). The Work Plan, which was prepared on your behalf by Stratus Environmental, Inc., presents plans to advance soil borings at seven locations to address data gaps previously identified by ACEH.

At this time, we request that the proposed scope of work in the December 6, 2013 Work Plan be placed in abeyance. ACEH is currently considering closure of this fuel leak case with no further site characterization activities. Case closure has been recommended by the State Water Resources Control Board Underground Storage Tank Cleanup Fund (Cleanup Fund). If case closure is considered appropriate, ACEH will notify you by beginning the landowner and public notification processes required for case closure.
