5/5/2006. John Russo and Mike Zimmerman of Clayton called at 3:07 pm. John Russo stated that soil samples were collected 2 feet below top of native soil. At many locations, there is 0.5 to 1.5 feet of concrete or pavement. Therefore, the samples collected 3 feet bgs were within 1 to 2 feet of native soil surface. He argues that metals are not a problem except at isolated locations. Wants me to consider going back out only to locations where there were shallow exceedances. Need to get back to them whether they need to submit something in writing or whether I will consider.

6/28/2006 Celia Villar called 408-417-2830. Owner of building, has one tenant. Wanted to know about "environmental impact report." Confirmed that she was calling in reference to the Revised Site Investigation Report prepared by Clayton rather than an environmental impact report. Wanted to know when she will get my report. Wanted me to call with results. Told her that I generally prepare correspondence with results of review.

She says that next tenant needs some type of "approval of environmental impact report" before moving in. Told her that we will review report to assess whether further work is needed or open SLIC case can be closed. GE told Celia that work was delayed due to "County bureaucracy."

Hit a clay pipe about 4 inches in diameter in center of excavtion at depth of about 2-3 feet bs. Pipe was dry and of unknown use. Pipe apparently meandered around the area as it was also observed in the side of the excavation. Also observed a culvert approximatel 3 feet bgs in northern portion of excavation. Excavation extends from about 2-3 feet from building wall to the property boundary. Visited the front yard and inside the building to see the sump excavations.
