We are writing to request an extension for the submittal of the Off-site Sampling Results Report due May 15, 2009. We have completed the "Permit to Enter" agreement ("Permit") with the Bay Area Rapid Transit District (BART) to access the MacArthur BART Station parking lot. However, we have not received the final approved Permit from BART at this time. Mr. Gary Anderson of BART indicated on May 12, 2009 that BART staff are in the process of reviewing the Permit and insurance certificates and that an update on the Permit approval should be available Friday May 15, 2009. Therefore, we are requesting an extension for the submittal of the Off-site Sampling Results Report to July 15, 2009. We have scheduled the drilling activities for the week of June 8, 2009, pending final approval of the Permit from BART.
