Dear Mr. Robinson and Mr. Coats:

Alameda County Environmental Health (ACEH) staff has reviewed the case file for the abovereferenced site, including the most recent report entitled, "Groundwater Monitoring Report No. 5 – 2nd Quarter 2010," dated April 29, 2010 (Groundwater Monitoring Report). The Groundwater Monitoring Report, which was prepared on your behalf by RM Associates, presents the results from groundwater sampling conducted on April 8, 2010. Based on the results of the April 8, 2010 groundwater sampling, the April 29, 2010 Groundwater Monitoring Report expressed an opinion that the site meets the criteria for low-risk case closure and indicated that a formal request for case closure would be submitted within 90 days. However, a formal request for case closure has not been received to date. In order for the site to be considered for case closure, please submit a Case Closure Review Report that addresses the technical comments below.

TECHNICAL COMMENTS

- Case Closure Request Report. We request that the Case Closure Request Report summarize the work performed to date and evaluate whether the site meets the criteria for low-risk closure. The adequacy of site characterization to define the extent of contamination and the stability of the associated plume must be included. Potential effects of the residual contamination on human health and the environment must be evaluated. This evaluation includes identification of nearby receptors, any sensitive receptors in the area of the site, and potential exposure pathways. Specific additional items to be addressed in the Case Closure Review Report are further described in technical comments 2 through 4.
- 2. Sensitive Receptors and Detailed Well Survey. Please identify any sensitive receptors such as schools, day care centers, or hospitals within 200 feet of your site. In order to identify potential receptors for groundwater contamination from your site, we request that you locate all water supply wells within a radius of 2,000 feet of the subject site. We recommend that you obtain well information from both the Zone 7 Water Agency and the State of

California Department of Water Resources. Submittal of maps showing the location of all wells identified in your study, and the use of tables to report the data collected as part of your survey are required. Please provide a table that includes the well designation, location, total depth, diameter, screen interval, date of well installation, current status, historic use, and owner of the wells. In addition, please provide well logs and completion records for wells downgradient from the site that are potential receptors. Results of the detailed well survey are to be included in the Case Closure Review Report Plan requested below.

- 3. **Product Lines.** The April 29, 2010 Groundwater Monitoring Report indicates that former product lines are believed to be associated with the gasoline release at the site. In the report requested below, please provide the background and basis for this statement. In addition, please show the location of the former product lines on a site plan.
- 4. Location of New Building. We note that a new building was constructed over a portion of the former tank pit and that the former tank pit is immediately adjacent to an off-site building to the east. In the Case Closure Review Report requested below, please review the tank removal results and extent of excavation during the tank removal to discuss the potential for vapor intrusion to the new on-site building and the off-site building.

REPORT REQUESTS

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

ELECTRONIC SUBMITTAL OF REPORTS

ACEH's Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of reports in electronic form. The electronic copy replaces paper copies and is expected to be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program FTP site are provided on the attached "Electronic Report Upload Instructions." Submission of reports to the Alameda County FTP site is an addition to existing requirements for electronic submittal of information to the State Water Resources Control Board (SWRCB) GeoTracker website. In September 2004, the SWRCB adopted regulations that require electronic submittal of information for all groundwater cleanup programs. For several years, responsible parties for cleanup of leaks from underground storage tanks (USTs) have been required to submit groundwater analytical data, surveyed locations of monitoring wells, and <u>other</u> data to the GeoTracker database over the Internet. Beginning July 1, 2005, these same reporting requirements were added to Spills, Leaks, Investigations, and Cleanup (SLIC) sites. Beginning July 1, 2005, electronic submittal of a complete copy of all reports for all sites is required in GeoTracker (in PDF format). Please visit the SWRCB website for more information on these requirements (<u>http://www.swrcb.ca.gov/ust/electronic_submittal/report_rqmts.shtml</u>.

PERJURY STATEMENT

All work plans, technical reports, or technical documents submitted to ACEH must be accompanied by a cover letter from the responsible party that states, at a minimum, the following: "I declare, under penalty of perjury, that the information and/or recommendations contained in the attached document or report is true and correct to the best of my knowledge." This letter must be signed by an officer or legally authorized representative of your company. Please include a cover letter satisfying these requirements with all future reports and technical documents submitted for this fuel leak case.

PROFESSIONAL CERTIFICATION & CONCLUSIONS/RECOMMENDATIONS

The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

UNDERGROUND STORAGE TANK CLEANUP FUND

Please note that delays in investigation, later reports, or enforcement actions may result in your becoming ineligible to receive grant money from the state's Underground Storage Tank Cleanup Fund (Senate Bill 2004) to reimburse you for the cost of cleanup.

AGENCY OVERSIGHT

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.

The Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities.

REQUIREMENTS

- Please <u>do not</u> submit reports as attachments to electronic mail.
- Entire report including cover letter must be submitted to the ftp site as a single portable document format (PDF) with no password protection.
- It is **preferable** that reports be converted to PDF format from their original format, (e.g., Microsoft Word) rather than scanned.
- Signature pages and perjury statements must be included and have either original or electronic signature.
- <u>Do not</u> password protect the document. Once indexed and inserted into the correct electronic case file, the document will be secured in compliance with the County's current security standards and a password.
 Documents with password protection <u>will not</u> be accepted.
- Each page in the PDF document should be rotated in the direction that will make it easiest to read on a computer monitor.
- Reports must be named and saved using the following naming convention:

Submission Instructions

- 1) Obtain User Name and Password
