The wells were destroyed, on March 02, 2012 under Zone 7 Water Agency Permit No. 2012010. The wells were destroyed by pressure grouting implemented by drilling contractor, Exploration Geoservices, Inc., San Jose, California, C-57 License No 484288. The destructions were performed under the direction and oversight of Mr. Jeff Jones of the Zone 7 Water Agency.


