Hi Joe,

I have reviewed the letter from ACEH answering the Closure Request we submitted in August 2013 for CPL Sunol, and have a few items for discussion.

- 1) it is unclear if ACEH is requesting a full groundwater sampling event of all site monitoring wells. As such, URS proposes that the first quarter is a full monitoring event to be completed in lieu of the March event, and the second quarter event be only new wells along Calaveras Road.
- 2) ACEH set the deadline for the First Quarter and Second Quarter reports to be due two weeks before the respective quarter ends. URS requests that the deadlines are extended by at least a six week for both reports, respectively April 25, 2014 and July 25, 2014.

URS will continue the monthly gauging events, and as soon as one of the monitoring wells has enough water for development URS will proceed with the development of the groundwater monitoring well(s). If water comes in for the other wells after the development of the first monitoring wells, URS will proceed to the Site for a second development of groundwater wells as necessary.
