Dear Mr. Hill:

This is a notice of enforcement referral for the subject site. Site Responsible Parties are non-responsive to Alameda County Environmental Health (ACEH) requests and are recalcitrant. The site has accumulated a series of enforcement actions. As a consequence, ACEH is referring this site to the San Francisco Bay Regional Water Quality Control Board for enforcement actions.

A Phase I report was prepared for the site in 2002 which identified the site as having been a retail service station from the 1940s to the 1990s. The underground storage tanks were left in place. A preliminary site assessment detected 160 mg/kg TPHg, 200 mg/kg TOG and 1 mg/kg benzene in soil samples and 1,500 µg/L TPHg in groundwater samples.

In 2006, Community Development of Oakland received orphan account funds for the site and conducted investigation work . However, no reports were ever submitted to Geotracker.

In 2008, ACEH requested compliance with Geotracker and subsequently submitted enforcement requests in 2009 and 2011 to claim the site and upload documents. The site remains unclaimed and no documents have been submitted. The Oakland CUPA and the USTCF do not have reports for the site. Community Development of Oakland is no longer solvent.
