### Responsible Party Identification Background

Alameda County Environmental Health (ACEH) names a "Responsible Party," as defined under 23 C.C.R Sec. 2720. Section 2720 defines a responsible party 4 ways. An RP can be:

- 1. "Any person who owns or operates an underground storage tank used for the storage of any hazardous substance."
- 2. "In the case of any underground storage tank no longer in use, any person who owned or operated the underground storage tank immediately before the discontinuation of its use."
- 3. "Any owner of property where an unauthorized release of a hazardous substance from an underground storage tank has occurred."
- 4. "Any person who had or has control over an underground storage tank at the time of or following an unauthorized release of a hazardous substance."

ACEH has named the responsible parties for this site as detailed below.

#### Existence of Unauthorized Release

On August 29, 2006, an Underground Storage Tank Unauthorized Release/Contamination Site Report was submitted for the site at 325 Martin Luther King, Jr. Way in Oakland, CA. During a Phase II Environmental Site Assessment, total petroleum hydrocarbons (TPH) as gasoline, TPH as diesel, and benzene, toluene, ethylbenzene, and xylenes were detected in soil and groundwater in the area of a former underground storage tank (UST). TPH as gasoline and TPH as diesel were detected in groundwater at concentrations up to 100,000 and 110,000 micrograms per liter, respectively. The petroleum contamination is within and downgradient of a UST that was abandoned in place in 1986. The former UST is within a warehouse building at 325 Martin Luther King, Jr. Way in Oakland, CA.

#### Responsible Party Identification

Kimball and Jane Allen are responsible parties for the fuel leak because they are the current owner of the property where an unauthorized release has occurred (Definition 3). Kimball and Jane Allen are the active or primary responsible parties.

Pucci Enterprises owned the property and operated a business on the property from 1981 to 2003. Pucci Enterprises is a responsible party because Pucci Enterprises owned or operated the UST immediately before the discontinuation of its use (Definition 2), the unauthorized release occurred during the time that Pucci Enterprises was the owner of property where an unauthorized release occurred (Definition 3), and Pucci Enterprises had control of USTs at the time of or following an unauthorized release (Definition 4).

Dear Kimball and Jane Allen and Teresa Pucci:

Alameda County Environmental Health (ACEH) staff has reviewed the case file for the above referenced site, including the work plan entitled, "Supplemental Investigation Work Plan," dated August 29, 2006, prepared on your behalf by LRM Consulting, Inc. The Work Plan proposes the installation of three monitoring wells. Verbal comments on the Work Plan were previously provided during a telephone conversation between Jerry Wickham of ACEH and Khaled Rahman of LRM Consulting, Inc. on November 16, 2006. Verbal comments were provided because Mr. Rahman indicated that monitoring well installation was scheduled for November 20, 2006 and expeditious review was requested. It is my understanding that the monitoring wells were not installed as planned.

The proposed installation of three monitoring wells is acceptable; however, monitoring well installation is limited in scope and will not complete site investigation. The horizontal and vertical extent of soil and groundwater contamination has not been defined for the site. Additional site investigation activities beyond installation of three monitoring wells will be required to complete site characterization. Recommendations for future site investigation activities will be required in the Soil and Groundwater Investigation Report requested below. We request that you address the following technical comments, perform the proposed work, and send us the reports described below.

#### REQUEST FOR INFORMATION

Several Phase I and Phase II reports refer to analytical data from two soil borings advanced at the site in May 2005 by AEI Consultants. However, no report by AEI Consultants has been submitted to ACEH. Please submit to ACEH, the report that presents the results from the AEI Consultants investigation.

# **TECHNICAL COMMENTS**

Previous Investigations and Reports. It appears that three phases of field investigations
have been conducted at the site by AEI Consultants in May 2005, by Terra Firma Consulting

> in September 2005, and by Ceres Associates in June 2006, respectively. investigations appear to have been conducted as part of due diligence for real estate transactions. As discussed in the previous Request for Information, the case file does not include a report for the AEI Consultants investigation. The Terra Firma Consulting report entitled, "Findings of Environmental Subsurface Investigation," dated September 16, 2005 minimally summarizes results and does not provide soil boring logs, a description of sampling methods, documentation of sample collection, handling, and analysis, or adequate discussion of encountered conditions. Due to the lack of documentation and reporting. results from the Terra Firma investigation as presented in the September 16, 2005 report, do not meet the minimum industry standards for site investigation data collection and reporting. These data should only be referred to qualitatively, at best, in future reports. The Ceres Associates report entitled "Soil and Groundwater Sampling Report," and dated June 8, 2006 does not include boring logs. Although ten borings have been advanced at the site, there are apparently no boring logs to describe subsurface conditions. Characterization of the site geology and hydrogeology at present is a significant data gap and is a requirement for the site that must be addressed during future site investigation.

- 2. Well Installation. The Ceres Associates report entitled "Soil and Groundwater Sampling Report," and dated June 8, 2006 includes a description of groundwater first being encountered 18 to 20 feet bgs but static levels following groundwater sampling were described as between 8 and 10 feet bgs. Soils are to be logged continuously in order to identify any potential confining layers and to carefully identify where groundwater is first encountered. Periodically stopping drilling to allow groundwater to enter the borehole may be necessary, depending upon encountered conditions. It is important that monitoring well filter packs and screens do not breach confining layers. Wells are NOT to be installed with filter packs extending from 5 to 20 feet bgs that allow ambient upward flow of groundwater from below a confining layer. In such a case, groundwater from below the confining layer could flow upward through the well bore to form a perched groundwater zone above the confining layer. Shallow perched groundwater could become contaminated if shallow soil contamination is present above the confining layer around the well. Water quality in groundwater samples from the shallow perched zone would not be representative of groundwater quality in the remainder of the site. If groundwater is not encountered until the lowermost interval of the well, the filter pack and well screen are to be constructed only within the lowermost interval where groundwater is encountered to avoid screening the well across a confining layer. In all cases, we request that the well screens and filter packs not exceed 10 feet in length.
- 3. Soil Samples. The Work Plan proposes the collection of soil samples at 5-foot intervals using a California modified split-spoon sampler. We request that soils be continuously logged and screened in the field. Soil samples are to be collected for laboratory analysis at significant vertical changes in soil type, the top of the capillary fringe, and from zones where visible staining, odor, or elevated PID readings are observed. If no visible soil staining, odor, or elevated PID readings are observed, a minimum of three soil samples are to be collected based on lithologic changes for laboratory analysis from each soil boring. Please present boring logs, well completion diagrams, screening results, and analytical data for soil samples in the Monitoring Well Installation Report requested below.

- 4. Proposed Laboratory Analyses. In addition to the proposed laboratory analyses of soil and groundwater samples for TPH as gasoline, TPH as diesel, and BTEX, we request that the soil samples be analyzed for total lead by EPA Method 6010B and for ethylene dibromide (EDB) and 1,2-dichloroethane (EDC) by EPA Method 8260. Groundwater samples are also to be analyzed for EDB and EDC by EPA Method 8260B. Analytical results are to be presented in the Monitoring Well Installation Report requested below.
- 5. Preferential Pathways. Please show on a site plan the subsurface utilities in the area of the former UST that potentially could act as preferential pathways for contaminant migration. The type, depth, and diameter of the utilities are to be included. The utilities site plan and discussion of the potential for the utilities to act as preferential pathways is to be presented in the Monitoring Well Installation Report requested below.
- 6. Horizontal Extent of Contamination. The horizontal extent of contamination has not been defined. Additional investigation will be required beyond the proposed monitoring wells to define the horizontal extent of contamination. Please present recommendations for additional investigation in the Monitoring Well Installation Report requested below.
- Vertical Delineation. Please present recommendations for additional future investigation to define the vertical extent of contamination in the Monitoring Well Installation Report requested below.
- Other Potential Sources. Please present recommendations for future investigation of other
  potential sources of contamination such as product lines and dispensers in addition to the
  closed in place UST. Such investigation may include a geophysical survey to look for
  product lines or unknown USTs.
- 9. Well Survey. We request that you locate all water supply wells (monitoring and production wells: active, inactive, standby, decommissioned, abandoned and dewatering, drainage and cathodic protection wells) within 2,000 ft of the subject site. We recommend that you obtain well information from both the Alameda County Public Works Agency and the State of California Department of Water Resources, at a minimum. Submittal of maps showing the location of all wells identified in your study, and the use of tables to report the data, including well construction details, collected as part of your survey are required. Well construction details are to include the well diameter, screen slot size, total depth of the boring, depths of the screened interval, depths of the filter pack, year of installation, and other construction details that may be relevant. The status of the water supply well, whether active, decommissioned, or unknown is to be included where known. Please present your results in the Monitoring Well Installation Report requested below.
- 10. Geotracker Submittals. A review of the SWRCB Geotracker website indicates that no data or reports have been submitted to Geotracker for your site. Pursuant to CCR Sections 2729 and 2729.1, beginning September 1, 2001, all analytical data, including monitoring well samples, submitted in a report to a regulatory agency as part of the LUFT program, must be transmitted electronically to the SWRCB Geotracker website via the internet. Additionally, beginning January 1, 2002, all permanent monitoring points utilized to collected groundwater samples (i.e. monitoring wells) and submitted in a report to a regulatory agency, must be surveyed (top of casing) to mean sea level and latitude and longitude accurate to within 1-

meter accuracy, using NAD 83, and transmitted electronically to the SWRCB Geotracker website. Beginning July 1, 2005, electronic submittal of a complete copy of all reports is required in Geotracker (in PDF format). Please upload all analytical data (collected on or after September 1, 2001) and a copy, in PDF format, of all reports prepared after July 1, 2005.

#### **TECHNICAL REPORT REQUEST**

Please submit technical reports to Alameda County Environmental Health (Attention: Mr. Jerry Wickham), according to the following schedule:

These reports are being requested pursuant to California Health and Safety Code Section 25296.10. 23 CCR Sections 2652 through 2654, and 2721 through 2728 outline the responsibilities of a responsible party in response to an unauthorized release from a petroleum UST system, and require your compliance with this request.

#### **ELECTRONIC SUBMITTAL OF REPORTS**

Alameda County Environmental Cleanup Oversight Programs (LOP and SLIC) require submission of all reports in electronic form to the county's ftp site. Paper copies of reports will no longer be accepted. The electronic copy replaces the paper copy and will be used for all public information requests, regulatory review, and compliance/enforcement activities. Instructions for submission of electronic documents to the Alameda County Environmental Cleanup Oversight Program ftp site are provided on the attached "Electronic Report Upload (ftp) Instructions." The California Business and Professions Code (Sections 6735, 6835, and 7835.1) requires that work plans and technical or implementation reports containing geologic or engineering evaluations and/or judgments be performed under the direction of an appropriately registered or certified professional. For your submittal to be considered a valid technical report, you are to present site specific data, data interpretations, and recommendations prepared by an appropriately licensed professional and include the professional registration stamp, signature, and statement of professional certification. Please ensure all that all technical reports submitted for this fuel leak case meet this requirement.

#### **UNDERGROUND STORAGE TANK CLEANUP FUND**

Please be aware that you may be eligible for reimbursement of the costs of investigation from the California Underground Storage Tank Cleanup Fund (Fund). In some cases, a deductible amount may apply. If you believe you meet the eligibility requirements, I strongly encourage you to call the Fund for an application.

#### **AGENCY OVERSIGHT**

If it appears as though significant delays are occurring or reports are not submitted as requested, we will consider referring your case to the Regional Board or other appropriate agency, including the County District Attorney, for possible enforcement actions. California Health and Safety Code, Section 25299.76 authorizes enforcement including administrative action or monetary penalties of up to \$10,000 per day for each day of violation.





Subsurface investigation of the site was conducted as part of due diligence activities associated with sale of the property. Investigation reports were not provided by the prospective buyers until recently. The results of the investigations indicate the presence of petroleum hydrocarbons in soil and groundwater beneath the site, with as much as  $100,000 \, \text{micrograms}$  per liter ( $\mu g/L$ ) total petroleum hydrocarbons as gasoline and  $110,000 \, \mu g/L$  total petroleum hydrocarbons as diesel in groundwater. Moreover, a Phase I assessment confirms the historical use and in-place closure of a UST at the site.

On behalf of the Allen family, LRM has prepared a Supplemental Investigation Work Plan for the subject property, which focuses on installation of three groundwater monitoring wells to further evaluate the magnitude and extent of hydrocarbons and to determine the direction of groundwater flow. Other activities proposed in the Work Plan include performing additional Phase I assessment, including review of historical aerial photographs, evaluation potential offsite sources, and interviews of available/knowledgeable employees of the prior site operators. Based on the findings of the activities proposed in the Work Plan, LRM will develop a site conceptual model and a plan for future investigation and/or corrective action, as necessary. Enrollment of the site in the State's UST Reimbursement Fund is also underway by Wendel, Rosen, Black & Dean, LLP, counsel to the Allens.





Lastly, to meet time constraints related to potential cost recovery activities associated with the purchase of the site, we would greatly appreciate your prompt review and approval of the Work Plan, so the planned work may be initiated and data compiled prior to the end of September 2006.
