Good Afternoon Mr. Wickham,

Hope all is well with you and yours. Just wanted to let you know that AEI is going to commence chemical oxidant injections at the above-referenced property the 16th of July. We will be out there all day and if all goes well we will be done in a day, however, if things don't go as planned (ie - the formation not accepting the injectant fluids very well), we may need to mobilize back another day (about a week later).

In addition, I recently spoke with the company who helped calculate the dosing required for the pilot test and we agreed on some minor fine-tuning. Instead of injecting 480 lbs as specified in the Corrective Action Pilot Test Work Plan, we are going to be injecting 720 lbs. Also, instead of doing process monitoring (sampling well MW-3) for once a week for four weeks following the final injections, we are going to sample this well (MW-3) twice, one and three weeks following the injections.
